Looking back over the past year, with social and economic activities returned to full normalcy after the epidemic, the Customs and Excise Department (C&ED) made remarkable and fruitful achievements in various aspects of work, particularly in narcotics interdiction, anti-illicit cigarettes, interception of smuggling activities, protection of consumer interests and intellectual property rights, collection of revenue on dutiable goods, implementation of the Smart Customs Blueprint, enhancement of trade facilitation measures, anti-money laundering, as well as the upholding of national security, Hong Kong's trading integrity and fulfilment of international obligations. Given the new global political and economic landscape, in order to dovetail with the overall national development and foster the Greater Bay Area development, we actively extend various trade facilitation measures and strive to explore mutually beneficial co-operation with both existing and new partners. C&ED has officially assumed the position of the World Customs Organization Vice-Chairperson for the Asia/Pacific Region in July 2024, playing a more significant role in the region and establishing closer multilateral co-operation with members in the region. We will remain dedicated and committed to achieving the goal of unveiling "a new chapter of Asia-Pacific customs collaboration".

This year marks the 10th anniversary of the promulgation of the holistic approach to national security. Apart from conscientiously discharging the duty to safeguard national security and serving the community, we will step up the promotion of national security education among our colleagues and Customs YES members to nurture a new generation of young people with an affection for our country and Hong Kong for contributing to the development of our nation and Hong Kong.

### **FOREWORD**

#### Law Enforcement

In 2023, C&ED detected a total of 19 120 cases, a 1.7-fold increase compared with 2022. About 62% of the cases were related to illicit cigarettes, followed by dangerous drugs (7%) and infringement of intellectual property rights (4%). During the year, C&ED seized around 9.5 tonnes of dangerous drugs and \$3.17 billion worth of smuggled goods, representing an increase of 37% and 1.4 times respectively over 2022. The mode of drug trafficking has evolved in recent years. Smugglers have resorted to a dual-track mode by using the tactics of "ants moving home" and large international consignments in parallel. Owing to the close co-operation and intelligence exchange with the Mainland and international law enforcement agencies, significant results have been achieved in combatting drug trafficking with a number of record-hitting cases detected.

#### **Trade Facilitation**

The Hong Kong Authorized Economic Operator (AEO) Programme of C&ED enables local enterprises to "go global" and open up international markets. C&ED has so far ratified AEO Mutual Recognition Arrangements (MRAs) with 14 economies, including the Mainland, and will further expand the coverage of the AEO Programme. Besides, C&ED actively promotes the Intermodal Transhipment of Air and Land Cargo, and will create a dedicated express route for air and land fresh and live products, which is expected to be implemented in the second quarter of 2024, to facilitate the movement of fresh and live products between overseas and the Greater Bay Area (GBA), providing two-way express transhipment and opening up business opportunities. The Alternative Smoking Product Transhipment Control Scheme implemented in June 2023 allowed the industry to transport 2 665 tonnes of alternative smoking products from the Mainland to the airport by land for overseas transhipment during the year. In the same month, the Mainland Customs and C&ED extended the Single E-lock Scheme to Hunan Province, and further launched the Guangdong-Hong Kong-Macao Three-Places-One-Lock Scheme in March 2024 to expedite logistics connectivity in the Guangdong-Hong Kong-Macao GBA.

#### **Consumer Protection**

C&ED received 18 982 complaints related to the Trade Descriptions Ordinance in 2023, representing a substantial increase of 2.1 times when compared with 2022. Following the full resumption of normal travel, complaints on medicine shops involving quantities of unclear pricing units in selling ginseng and dried seafood, or Chinese medicine increased significantly. In this regard, Quick Response Teams were deployed, where appropriate, to promptly follow up on complaints lodged by visitors for the protection of consumer interests. Meanwhile, C&ED was committed to promoting publicity and education to enhance consumers' awareness of the Trade Descriptions Ordinance.

#### Mainland/International Co-operation

C&ED proactively maintained strong ties and close co-operation with the Mainland Customs and international law enforcement agencies and organised a number of large-scale international events in 2023, including the Regional Customs High-level Drug Enforcement Forum in February, the Regional Drug Enforcement Capacity Building Workshop in September, and the AEO Expert Mission and Symposium for ASEAN and Hong Kong, China in November. In March 2024, we successfully hosted the 6th World Customs Organization (WCO) Global Canine Forum which was held for the first time in Asia. The Secretariat Office of the WCO Vice-Chairperson for the Asia/Pacific Region will be established in July the same year to organise more international conferences at global or regional level.



#### **Smart Customs**

C&ED continued to forge ahead with the Smart Customs Blueprint by introducing more advanced inspection equipment and facilities, including the Smart Under Vehicle Robot for detecting contraband, the Smart Seizure Management System for managing seizure in prosecution cases, as well as the Smart Customs Interactive Response System which is applied to the virtual Customs Service Ambassadors and the online chatbot on the Customs website for handling public enquiries.

#### **Human Resources Management**

C&ED has strived to deepen the understanding of safeguarding national security, customs affairs and national affairs among all staff members. We arranged training on national studies and Mainland customs operations at the Shanghai Customs College for all newly appointed Customs Inspectors; sent serving officers to attend training at various universities, the National Academy of Governance and the leadership academy in the Mainland; and organised seminars, training videos and competitions to enhance their knowledge, understanding and comprehension of the spirit of the 20th National Congress and integrate it into the goals, actions and attitudes of our work.

#### Serving the Community and Engaging the Youth

To reach out to more netizens, C&ED launched its Douyin account in April 2023 following the setting up of our YouTube channel, Facebook page and Instagram account. Besides, the C&ED Volunteer Team actively engaged in charities and volunteer work. Apart from supporting local sports events, they also provided services for grassroots families and elderly people.

Customs YES encourages young people to unleash their full potential and seeks to nurture their sense of belonging to and patriotic feelings for the country. More than 5 500 members have been recruited. Following the full resumption of normal travel, Customs YES organised an exchange tour to the Guangdong-Hong Kong-Macao GBA and a summer study tour to Xian, Dunhuang and the Silk Road in March and July 2023 respectively to deepen members' understanding of the profound history and culture of our country, and strengthen their sense of national identity, thereby developing them into distinguished leaders with a sense of social responsibility to make contribution to the country.

#### Challenges ahead

Looking forward to the coming year, C&ED has assumed the position of the WCO Vice-Chairperson for the Asia/Pacific Region in July 2024 and will strengthen co-operation with other Customs counterparts in the Asia-Pacific region. Apart from guarding the gateway and our nation, we will spare no effort in reinforcing intermodal transhipment, enhancing existing trade facilitation measures and assisting the business sector in exploring international markets to support the development of our motherland and Hong Kong.

Apart from covering an additional 28 types of trade documents, Phase 2 services have incorporated new functions to enhance user experience. These include the "user pool" management function, "batch upload" function, full support for the "iAM Smart" Platform and seamless interface with the information systems of relevant government departments.

The integration of Smart Customs also helps expand the scope of cross-boundary collaboration between both Customs administrations.



#### Organisation of the Department

The Commissioner of Customs and Excise is the head of C&ED. She is assisted by two Deputy Commissioners in handling departmental affairs.

Deputy Commissioner (Management and Strategic Development) heads the Administration and Human Resource Development Branch, the Excise and Strategic Support Branch and two formations under his direct charge, namely the Office of Quality Management and the Internal Audit Division. He is responsible for the overall administration and management of the Department and oversees the planning and development of departmental infrastructure projects.

Deputy Commissioner (Control and Enforcement) heads the Boundary and Ports Branch, the Intelligence and Investigation Branch and the Trade Controls Branch. He is responsible for the overall control and enforcement issues of the Department, and supports the Commissioner of Customs and Excise in handling matters on operations and strategies in relation to safeguarding national security.

The Department comprises five branches, each under a directorate officer.

The Administration and Human Resource Development Branch, headed by Assistant Commissioner (Administration and Human Resource Development), is responsible for departmental administration; financial management; human resource management; central support; training and recruitment; legislation, orders and procedures as well as matters on the systems of the Department; prosecution of Customs and Excise (C&E) Service cases; investigation of public complaints; and integrity management.

The Boundary and Ports Branch, headed by Assistant Commissioner (Boundary and Ports), is responsible for matters regarding Customs control and facilitation functions at all entry and exit points, and implementation of departmental policies in relation to Customs control and facilitation functions at all entry and exit points.

The Excise and Strategic Support Branch, headed by Assistant Commissioner (Excise and Strategic Support), is responsible for matters regarding revenue protection and excise control, information technology development, planning and development of major departmental projects, supply chain security management, trade relations and public communication, customs liaison and international

co-operation, operation of the Trade Single Window, and co-ordination of agency services.

The Intelligence and Investigation Branch, headed by Assistant Commissioner (Intelligence and Investigation), is responsible for matters regarding the suppression of narcotics offences and control of precursor chemicals, protection of intellectual property rights, recovery and confiscation of proceeds arising from drug trafficking and organised crimes, risk management and departmental intelligence activities, suppression of syndicated smuggling activities, enforcement activities relating to revenue protection, supervision of the dealers in precious metals and stones, and suppression of money laundering activities.

The Trade Controls Branch, headed by the Head of Trade Controls, is responsible for matters regarding trade inspection, verification, investigation and prosecution relating to origin fraud / licensing fraud / trade fraud, including cases involving Certificates of Origin under the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA); consumer protection; control of strategic commodities and reserved commodities; supervision of money service operators; and import and export trade declaration.

Moreover, in response to C&ED's assumption of the position the World Customs Organization (WCO) Vice-Chairperson for the Asia/Pacific (A/P) Region from July 2024 to June 2026, the Secretariat Office of the WCO Vice-Chairperson for the A/P Region was established. Headed by Assistant Commissioner (World Customs Organization), the Secretariat Office is responsible for driving regional development agendas, coordinating regional affairs, leading members in addressing various challenges and facilitating the formulation and implementation of regional strategic plans.



## Contact Law Enforcement

cae shoulders a diverse scope of enforcement duties. Customs officers fight the menaces to our society by way of boundary control, anti-smuggling and counter-money laundering, narcotics interdiction, as well as intellectual property rights and revenue protection. The prompt and effective law enforcement aims not only to protect society and fight against transnational crime but also to provide a safe business environment.



### Anti-smuggling

C&ED prevents and detects smuggling activities under the Import and Export Ordinance by inspecting cargoes imported and exported by air, land and sea; examining passengers and their baggage at entry/exit points; and searching aircraft, vessels and vehicles entering and leaving Hong Kong, so as to enforce the licensing controls on prohibited articles.

In 2023, 221 cases of importing or exporting unmanifested cargo under the Import and Export Ordinance were detected. A total of 188 arrests were made with a total seizure value of about \$3.165 billion. Generally speaking, Mainland-Hong Kong cases accounted for around 83% of the total number of smuggling cases and the total value of the goods seized was \$2.676 billion. Among the seized items, electrical appliances and electronic products (including mobile phones, computers and accessories) were the most popular ones, followed by cigarettes and tobacco products.

#### Sea Smuggling Activities

During the epidemic, smuggling syndicates switched to seaborne smuggling due to the travel restrictions imposed on passengers and land transport channels. In order to evade Customs detection, they kept changing both the conveyance types and smuggling routes. Despite the full resumption of normal travel in early 2023, smuggling syndicates have still frequently used sea routes for smuggling as it is believed that sea smuggling enables them to transport larger quantities of goods in a single trip. In 2023, C&ED detected 46 sea smuggling cases, with a total seizure value amounting to \$2.17 billion.

In June 2023, C&ED detected a case involving the use of an ocean-going vessel (OGV) to smuggle goods to the Mainland via Singapore. A large batch of smuggled goods, including electronic products, high-value food ingredients, wines, records and scheduled endangered species, was found in 15 containers prepared to be shipped to Singapore, with an estimated retail value of about \$1.5 billion. This is the largest smuggling case detected by C&ED on record in terms of the retail value of the smuggled goods seized.









A large batch of smuggled goods with a retail value of \$21 million was seized in a RTV smuggling case.

In February 2023, C&ED detected a case involving the use of an OGV to smuggle goods to Malaysia at the Kwai Chung Container Terminals. A large batch of suspected smuggled goods, including electronic waste, vehicle parts and TV set-top boxes, was found inside two containers on board the vessel, with an estimated retail value of about \$17 million.

In addition to using OGVs, smuggling syndicates also engaged in smuggling activities by using river trade vessels (RTVs). In April 2023, C&ED intercepted a RTV heading for Macao in the western waters of Hong Kong. Upon inspection, Customs officers found a large batch of suspected smuggled goods, including notebook computers, notebook computer parts, frozen meat, beef jerky and sea cucumbers, in two containers on board the vessel, with an estimated retail value of about \$21 million.

In the same month, C&ED detected another smuggling case involving the use of a RTV. C&ED intercepted a RTV, preparing to enter the waters of the Mainland, in the western waters of Hong Kong. Upon inspection, Customs officers found a large batch of suspected smuggled goods, including smart phones, computers and integrated circuits, in five containers on board the vessel, with an estimated retail value of \$16 million.

C&ED has successively cracked down on a number of cases involving the use of RTVs to smuggle goods to the Mainland. In order to evade Customs detection, smuggling syndicates have shifted their smuggling routes by firstly transporting the smuggled goods from Hong Kong to Macao, and then smuggling them into the Mainland. To curb related smuggling activities, C&ED mounted an enforcement operation codenamed "Clear Sky" from April to May 2023, focusing on the detection of smuggling activities involving RTVs and OGVs, and detected one RTV case and two OGV cases at the Kwai Chung container terminals.

In the first case, through intelligence exchange with Macao Customs, C&ED successfully intercepted a RTV departed from Hong Kong and returned from Macao. A batch of scheduled dried shark fins and controlled drugs was found in four containers on board the vessel. In another two cases, a large batch of suspected smuggled goods, including set-top boxes, routers, servers, vehicle parts and batteries, was found in 25 containers prepared to be shipped to Malaysia on two OGVs. The retail value of the smuggled goods seized in the operation was estimated at about \$230 million.

Despite that RTVs and OGVs have been mainly used for smuggling, cases of smuggling involving the use of speedboats still occurred. In June 2023, C&ED successively detected two smuggling cases involving speedboats in Yau Tong and Aberdeen. The first case occurred in the Yau Tong Industrial Area, where Customs officers discovered several suspicious individuals moving a batch of goods from the shore to a speedboat, and they then took enforcement action. A batch of suspected smuggled goods, including red coral, dried fish maws, bird's nests, dried shark fins and used mobile phones, with an estimated retail value of about \$16 million, was seized in a nearby open space and inside a light goods vehicle. Subsequently, C&ED conducted a joint operation with the Marine Police at the Aberdeen Fish Market and found several suspicious individuals moving a batch of goods from the shore to a speedboat. A batch of suspected smuggled goods, including dried seafood and electronic products, with an estimated retail value of about \$15 million, was seized on the shore.

C&ED spares no effort to combat smuggling activities. From August to September 2023, C&ED launched an enforcement operation codenamed "Wave Breaker", during which C&ED conducted surprise searches on three OGVs travelling from Hong Kong to Malaysia, one OGV traveling from Hong Kong to Shanghai, and two RTVs heading for Nansha and Macao respectively. Upon inspection, C&ED seized a large batch of suspected smuggled goods, including electronic products, wines, electronic waste, scheduled shark fins and frozen meat on these six vessels, with an estimated retail value of \$100 million.







A large batch of smuggled goods was seized in an enforcement operation codenamed "Wave Breaker", with a retail value of about \$100 million.

In October 2023, C&ED detected a suspected case involving the smuggling of goods to Malaysia with an OGV at the Kwai Chung Container Terminals. A large batch of suspected smuggled goods, including electronic components, electronic waste and fabrics, was found in five containers on board the vessel, with an estimated retail value of about \$53 million.

#### **Endangered Species**

As for endangered species, 403 cases were detected during the year. C&ED seized 1.56 tonnes of endangered species with an estimated value of about \$81.6 million. A total of 276 persons were arrested.



A total of 1 270 kg of suspected scheduled shark fins with a retail value of about \$39.8 million were seized at Hong Kong International Airport.

### Alternative Smoking Products

During the year, C&ED detected 1562 cases involving alternative smoking products (ASPs) and seized about 3.85 million ASPs with a value of \$24.47 million. A total of 1277 persons were arrested.





Around 33 000 suspected alternative smoking products with a retail value of \$1 million were seized at the Heung Yuen Wai Boundary Control Point.

### Firearms and Ammunition/ Strategic Commodities

C&ED has all along maintained stringent controls on firearms and ammunition to prevent illegal import and export of such items into or out of Hong Kong. In 2023, a total of 33 cases involving illegal firearms, firearm component parts and ammunition were detected, representing an increase of 74 per cent over 2022. Meanwhile, the number of cases involving strategic commodities decreased from 126 in 2022 to 57 in 2023.

To further enhance enforcement effectiveness and counter-terrorism capabilities, explosive detector dogs and firearm detector dogs have been deployed to various Customs clearance points to assist in combating the smuggling of illegal firearms, firearm component parts, ammunition and explosives into Hong Kong, with a view to protecting the lives and property of the public as well as safeguarding national security.

#### Strategies for Suppressing Smuggling

C&ED strives to combat smuggling activities and keeps on strengthening liaison and co-operation with the logistics industry. C&ED signed a memorandum of understanding (MoU) with five major express courier operators in Hong Kong to strengthen enforcement capabilities in combatting smuggling by courier services. Moreover, in order to establish ties and enhance co-operation with the local logistics industry in combatting Customs offences more effectively, the Customs Liaison Programme (CLP) was set up under the Intelligence Bureau in August 2020. As a result of the MoU and CLP, C&ED successfully detected 203 smuggling cases under the Dangerous Drugs Ordinance, the Import and Export Ordinance, the Dutiable Commodities Ordinance, the Trade Descriptions Ordinance, the Weapons Ordinance and the Firearms and Ammunition Ordinance with a seizure value over \$44 million in 2023.

C&ED has established an intelligence exchange and sharing mechanism with law enforcement agencies in the Mainland. In 2023, C&ED worked closely and effectively with the Anti-Smuggling Bureau (ASB) of the General Administration of Customs of the People's Republic of China (GACC), the ASB of the Guangdong Sub-Administration of GACC, the ASB of Shenzhen Customs and the Macao Customs in mutual assistance in law enforcement with remarkable results.

To further combat smuggling activities of parallel traders, a joint operation codenamed "Yunzhan-qingliu" was mounted by the law enforcement agencies of Hong Kong and the Mainland. In April and July 2023, through intelligence exchange with the ASBs of the Mainland, C&ED assisted ASBs in apprehending 60 suspects. A large quantity of smuggled goods, including lobsters, red wine and cosmetics, with a total retail value exceeding RMB 1.11 billion, was seized.

### Narcotics Interdiction

In 2023, 1 362 drug cases were detected, representing an increase of 46 per cent over 2022. A total of 296 persons were arrested and 9 476 kg of drugs were seized, representing an increase of 66 per cent and 37 per cent respectively as compared with 2022.

Major seizures were cannabis (2 423 kg, an annual increase of 2 times), methamphetamine (ice) (2 212 kg, an annual decrease of 29 per cent), cocaine (2 058 kg, an annual increase of 1 time), ketamine (1 809 kg, an annual increase of 1.9 times) and heroin (332.5 kg, an annual increase of 2.6 times).

A total of 5 046 kg of illicit drugs were seized at the airport, representing an annual increase of 94 per cent and accounting for about 53 per cent of the total drug seizures in the year; and 3 703.5 kg of illicit drugs were seized via seaborne channels, representing an annual increase of 25 per cent and accounting for about 39 per cent of the total drug seizures in the year. A total of 60 significant cases with seizure value over \$10 million were detected in 2023.





#### **Anti-narcotics Strategy**

C&ED has adopted a comprehensive enforcement strategy to prevent and detect illicit drug trafficking, including drug source detection, recovery of drug/crime proceeds and control of precursor chemicals used in manufacturing of illicit drugs.

While stringent control is imposed at all control points to prevent the smuggling and transiting of drugs, officers of the Customs Drug Investigation Bureau also take action against drug syndicates and street peddlers based on surveillance and intelligence.

C&ED is empowered to trace, restrain and confiscate drug and crime proceeds derived from illicit activities so as to stop drug traffickers from re-investing the drug proceeds for further drug trafficking and other criminal activities or using Hong Kong as a base for money laundering.

Through international intelligence exchange and law enforcement collaboration, C&ED maintains solid partnerships with overseas and regional law enforcement agencies (LEAs) to combat transnational drug trafficking activities. Moreover, to strengthen the drug enforcement capacity of LEAs in the Asia-Pacific region, C&ED hosted a Regional Drug Enforcement Capacity Building Workshop in September 2023.





By hosting the Regional Drug Enforcement Capacity Building Workshop, C&ED brought together 44 representatives mainly from 24 LEAs (including those from the Mainland, Asia-Pacific countries and regions and overseas offices stationed in the Asia-Pacific region), as well as international organisations (including the International Narcotics Control Board and the World Customs Organization).

#### **Enforcement Actions**

Frontline Customs officers take enforcement actions against illicit drugs based on intelligence and combat drug trafficking activities with the use of hi-tech equipment. Apart from focusing on high-risk commercial cargoes, Customs officers also target the smuggling of drugs by express and mail parcels as well as drug traffickers who attempt to smuggle drugs through control points by wrapping drugs around the body, stuffing drugs inside body cavities or concealing drugs in false compartments of baggage.

Since the resumption of normal travel in early 2023, the smuggling of drugs by air passengers has resumed. Meanwhile, the use of large consignments, air express and speedpost parcels for the smuggling of drugs continues. C&ED has adjusted enforcement strategies in a timely manner and strengthened intelligence exchange and collaboration with the Mainland and overseas LEAs to combat drug trafficking activities at source and to trace illicit fund flows of drug syndicates through financial investigation.

In 2023, seven cases (six seaborne and one local cases) with seizure value of \$100 million or above each were detected. The total seizure value of these seven cases was about \$2.3 billion. Methamphetamine, cocaine, cannabis, ketamine and heroin, are the dangerous drugs most commonly smuggled into Hong Kong.

In 2023, C&ED seized 2 212 kg of methamphetamine and arrested 54 persons. In October 2023, Customs officers intercepted a seaborne container, declared as carrying seafood, arriving in Hong Kong from Mexico, and seized about 1.1 tonnes of methamphetamine with a retail value of about \$640 million. This is the largest-ever solid methamphetamine case detected by C&ED.



In 2023, C&ED seized 2 058 kg of cocaine and arrested 120 persons, representing an increase of 100 per cent and 71 per cent respectively when compared with the figures of 2022. In December 2023, Customs officers intercepted a seaborne container, declared as carrying wine and grape juice, arriving in Hong Kong from Brazil, and seized 444 kg of liquid cocaine with a retail value of about \$490 million.





C&ED and the Hong Kong Police Force jointly seized 318 kg of cocaine with a retail value of about \$390 million.

In 2023, C&ED seized 2 423 kg of cannabis and arrested 62 persons. Among the seizures, 1 341 kg were intercepted at Hong Kong International Airport (HKIA) and 1 000 kg were seized via seaborne channels. In October 2023, Customs officers intercepted a seaborne container, declared as carrying air compressors, arriving in Hong Kong from Northern America, and seized 484 kg of assorted drugs, including about 311 kg of cannabis buds, 88 kg of methamphetamine, 82 kg of MDMA and 3.2 kg of fentanyl, with a retail value of about \$140 million.

In 2023, C&ED arrested 77 persons and seized 1809 kg of ketamine. The amount of seizure increased by 1.9 times when compared with that in 2022. In October 2023, Customs officers conducted an antinarcotics operation in Kwai Chung and seized about 100 kg of ketamine and about 1.4 kg of cannabis buds with a retail value of about \$52 million.

In 2023, about 332.5 kg of heroin were seized, mostly from Thailand and Malaysia, and 42 persons were arrested. Among the seizures, 264.5 kg were seized at HKIA, 54.1 kg were seized locally and 13.5 kg were seized via seaborne channels.

### Co-operation with the Mainland and Overseas Authorities

As transnational drug cartels are highly organised and collude among themselves, drug trafficking activities have become more internationalised and cartelised. As a result, there is a significant increase in the number of major cases by air or by sea detected in recent years. The amount of drug proceeds involved is also increasing. Hong Kong is not alone in this regard as the entire Asia-Pacific region is facing the same challenge. Regional law enforcement co-operation is particularly important to effectively combat drug trafficking activities.

C&ED has maintained close ties with the LEAs in the Mainland and overseas to fight against transnational drug trafficking. In 2023, through co-operation with other jurisdictions, about 1 460 kg of drugs were seized outside Hong Kong.

In February 2023, C&ED detected a significant case in a joint operation codenamed "Yunzhanduanliu 2023" with the Anti-Smuggling Bureau (ASB) of the General Administration of Customs of the People's Republic of China (GACC), the ASB of the Guangdong Sub-Administration of GACC, the ASB of Shenzhen Customs and the Narcotics Control Bureau of the Public Security Department of the Guangdong Province. Through intelligence exchange with the Mainland counterparts, C&ED assisted the ASB of Shenzhen Customs in intercepting a seaborne consignment containing 452.3 kg of methamphetamine, and four persons were arrested in Sydney by the Australian LEA through subsequent international controlled delivery operations.

In July 2023, Customs officers intercepted a seaborne container, declared as carrying synthetic leather rolls, arriving in Hong Kong from Mexico, and seized 240 kg of methamphetamine with a retail value of about \$170 million. Three persons were arrested by C&ED, and one person was arrested in Sydney by the Australian LEA with the assistance of C&ED through subsequent international controlled delivery operations.

Between September and November 2023, C&ED also mounted a joint anti-narcotics operation codenamed "Operation Marker" with 31 LEAs in the Mainland, Asia-Pacific countries and regions, overseas offices stationed in Hong Kong and the Regional Intelligence Liaison Office of the World Customs Organization. About 2 849.2 kg of drugs were seized in the operation.

#### **Control of Cannabidiol**

With effect from 1 February 2023, cannabidiol (CBD) is under the control of the Dangerous Drugs Ordinance. As such, C&ED has taken proactive enforcement actions against CBD smuggling. In 2023, 40 cases were detected, and about 119.5 kg of products suspected of containing CBD were seized.

Besides, C&ED has actively organised various types of publicity programmes. On preventive education, we held around 18 anti-drug talks in different schools and organisations to promote anti-drug messages in 2023. In addition, we organised activities with Customs YES to remind the public of the harmful effects of drugs and the control of CBD through legislation.

#### **Control of Chemicals**

C&ED maintains a licensing system under the Control of Chemicals Ordinance to regulate the trade of 36 chemicals commonly used for the illicit manufacturing of narcotic drugs and psychotropic substances. C&ED has been proactively exchanging information and intelligence with overseas LEAs on suspicious shipments of precursor chemicals sourced in the region and shipped through Hong Kong to high-risk destinations.

In 2023, C&ED took part in several international tracking programmes. These initiatives, organised by the United Nations International Narcotics Control Board, are recognised as an effective multilateral mechanism in preventing the illicit diversion of precursor chemicals.

# Intellectual Property Rights Protection

On intellectual property rights (IPR) protection, 703 infringing cases were detected and 329 arrests made in 2023. About 0.73 million infringing items were seized, with a total seizure value amounting to around \$288 million, representing an increase of 60 per cent over 2022. Major seizures included electrical appliances and electronic products, followed by watches and parts.

In the light of the newly implemented Copyright (Amendment) Ordinance 2022, to effectively combat unauthorised communication of copyright works, C&ED has commissioned The University of Hong Kong to conduct research on illicit streaming activities and develop evidence-gathering and analysis systems for illicit streaming. The project was completed in June 2023. It helped enhance the capability of Customs officers to carry out cyber investigation and process digital evidence. In October 2023, C&ED conducted a special operation against infringement activities involving illicit streaming devices by applying the "communication right" for the first time in enforcement operations. C&ED will continue to monitor unauthorised communication of copyright works with illicit streaming devices and any suspected infringing cases, and maintain close liaison with copyright owners. If any suspected local infringement activities are found, C&ED will gather evidence in various aspects under the existing legal framework and take appropriate enforcement actions should there be sufficient evidence.



#### Actions against Online IPR Infringements/ Technology Crimes

To cope with the upward trend of online IPR infringement crimes, the "Anti-Internet-Piracy Team" of C&ED was established in 2000 and further expanded its scale in 2014 with more than 40 investigators dedicated to fighting against online IPR infringements/technology crimes.

#### **Online Counterfeiting**

In view of the growing popularity of online shopping in recent years, C&ED has actively conducted enforcement operations against online counterfeiting. Investigations revealed that counterfeit goods were mostly offered for sale on online market places and social media platforms. Culprits solicited business in the name of online shopping agents and claimed that they had connections with overseas suppliers or shopping agents from whom they could source the goods directly. Some also claimed that the goods were sourced directly from original manufacturers and therefore could be sold at lower prices. Counterfeit goods were promoted as "goods purchased by agents" or "goods from original manufacturers" and were put for sale at different discounted prices to attract customers on online platforms.

In 2023, C&ED detected a total of 77 online counterfeiting cases with 87 persons arrested. A variety of counterfeit goods including leather goods, clothes, footwear, accessories, perfumes and cosmetics products, with a total seizure value of \$6.62 million, were seized.

#### Online Piracy/Technology Crimes

C&ED has spared no effort in combating online piracy and technology crimes. In 2023, C&ED detected a total of 24 cases with 29 persons arrested and pirated goods valued at \$2.45 million seized. The cases mainly involved the sale of circumvention devices and illicit streaming devices, and the provision of infringing karaoke songs to customers by party room and restaurant operators in the course of business for attracting more customers to increase profits.



An enforcement operation was taken in October 2023 to combat infringement activities involving unauthorised communication of copyright works to the public. Ten retail shops were raided with a seizure of about 1 500 suspected illicit streaming devices and a batch of computers and audio-visual equipment, with an estimated market value of about \$1.74 million.



#### Online Monitoring Systems

To cope with emerging enforcement challenges arising from advancement in technologies, C&ED set up the Electronic Crime Investigation Centre (ECIC) in 2013. The ECIC aims to strengthen research on the latest modus operandi of cybercrimes, formulate enforcement strategies and evidence collection procedures for frontline enforcement officers, organise training courses on retrieval and preservation of digital evidence for frontline officers and develop online monitoring systems to assist frontline officers in conducting cyber investigation.

In 2017, the ECIC implemented the "Big Data Analytics System" to collect and analyse massive information retrieved from various Internet platforms in order to combat the ever-changing online IPR infringement activities. The system has been running well since its implementation. In 2023, the system detected 43 online infringing cases, accounting for 43 per cent of the online infringing cases during the year. This contributed to a seizure value of \$2.61 million, which constituted 29 per cent of the total seizure value from online infringing cases.

The ECIC has obtained the ISO 9001:2015 Quality Management System Accreditation since 2017, demonstrating its commitment to quality and compliance with international standards.



### Actions against Local IPR Infringements

Regarding actions against local trademark counterfeiting activities, C&ED detected 202 cases involving forged trademarks with 170 persons arrested in 2023. The goods seized were mainly clothes and accessories, watches and parts, as well as electrical appliances and electronic products, with a total seizure value of \$11.44 million.

In respect of actions taken against local copyright infringement activities, C&ED detected 25 local piracy cases with 31 persons arrested during the year. On pirated optical discs (PODs), with the stringent enforcement actions taken by C&ED, the retail outlets selling PODs have almost been wiped out in recent years.

### Actions against Cross-boundary IPR Infringements

In 2023, 400 cross-boundary infringement cases were detected with a total seizure of 0.62 million items of counterfeit goods, valued at \$267 million, mainly comprising electrical appliances and electronic products, watches and parts, footwear, clothes and accessories.

Three rounds of special enforcement operations codenamed "Tracer" targeting high risk transhipping and local consignments in devanning compounds were mounted by C&ED in 2023. A total of 68 cases were detected with a total seizure of about 246 000 items of counterfeit goods, valued at around \$150 million

The Customs administrations of Guangdong, Hong Kong and Macao have been working closely to exchange views and share experience on enforcement and strategy for IPR protection. A video conference was held between C&ED and the Intellectual Property Rights Department of the Macao Customs Service in September 2023 to discuss and exchange views on cross-boundary collaboration and strategies in combating IPR cases. During the year, three joint operations were conducted by the Customs administrations of Guangdong, Hong Kong and Macao. A total of 72 cases were detected with a total seizure of about 541 000 items of counterfeit goods, valued at around \$25.4 million.

# Restraint and Confiscation of Crime Proceeds of IPR Infringing Syndicates

C&ED actively applies the Organized and Serious Crimes Ordinance (OSCO) in the investigation of IPR infringement cases in the fight against organised syndicates engaged in piracy and counterfeiting activities. Since the first application of OSCO to a piracy case in 2004, C&ED has applied this Ordinance to a total of 19 IPR cases (11 copyright cases and 8 counterfeit cases), with some \$140.4 million worth of crime proceeds/assets restrained. This enforcement approach has effectively clamped down on syndicates engaged in copyright piracy and trademark counterfeiting activities.

## Strategic Partnership

C&ED has been proactively seeking greater co-operation with the IPR industry to step up efforts to curb piracy and trademark counterfeiting activities. The industry is now providing all sorts of support to C&ED, including the provision of leads on IPR infringing activities, examination of seized goods to authenticate IPR, provision of testimony in court and training for Customs officers to enhance their skills in identification of fake products. C&ED has also actively maintained close liaison with the industry, local and overseas law enforcement agencies, academics, etc. to review the effectiveness of Customs enforcement, re-examine IPR protection issues and exchange views from multiple perspectives.

During the year, C&ED co-organised six seminars with industry bodies/organisations, including the Korea Trade-Investment Promotion Agency and the Japan External Trade Organization, with the aim of enhancing the ability of frontline enforcement officers in identifying relevant counterfeit products and maintaining active and close communication with the industry.



In July 2023, a trademark owner representative briefed Customs officers on the brand protection strategy of his trademark at a seminar on IPR protection jointly organised by C&ED and the Korea Trade-Investment Promotion Agency.



The ECIC has been deploying resources to conduct insightful research on technology crimes and seeking opportunities to organise training programmes and experience sharing sessions with overseas law enforcement agencies, partners in the business sector as well as academic institutions.

In 2023, C&ED achieved good progress in its partnership with the IPR sector with on-going collaboration in the following areas. The Intellectual Property Rights Protection Alliance (IPRPA) established by C&ED and the industry in March 2004 provides a platform for fostering strategic partnership and strengthening intelligence exchange. As at the end of 2023, 66 organisations of the IPR sector have joined the IPRPA. A working committee was established under the IPRPA to organise activities related to IPR protection, including the launch of publicity and educational campaigns to raise social awareness of IPR protection. In 2023, C&ED organised a visit for the IPRPA members to the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port to give them a better understanding of the Customs work at the boundary control point.

The "Fast Action Scheme" launched jointly with the Hong Kong Brands Protection Alliance in July 2006 effectively protects the interests of IPR owners participating in major exhibitions and trade fairs staged in Hong Kong. Under the scheme, C&ED will take prompt enforcement actions when reports on IPR infringing activities from exhibitors are received. Publicity leaflets are distributed to exhibitors at the opening of exhibitions to highlight the penalties for IPR infringement offences and to encourage exhibitors to report IPR infringing acts. Since the implementation of the scheme, C&ED has activated the "Fast Action Scheme" at 144 major exhibitions and trade fairs, leading to the detection of 190 infringement cases and the arrest of 227 persons.

### **Reward Schemes**

The IPR industry and C&ED are joining forces to step up intelligence collection with a view to reinforcing actions against IPR infringement offences. The industry is now sponsoring reward schemes which pay cash rewards to informers who provide C&ED with information that leads to the seizure of infringing goods. The three existing reward schemes are:

- Anti-piracy (except retail level) Reward Scheme sponsored by the copyright industry;
- Reward Scheme to Combat Illegal Photocopying of Books and Periodicals sponsored by the Hong Kong Reprographic Rights Licensing Society;
- Reward Scheme to Combat Illegal Photocopying of Newspapers and Magazines sponsored by the Hong Kong Copyright Licensing Association.

# Combating Unfair Trade Practices

In 2023, C&ED received 18 982 complaints related to unfair trade practices (16 224 on goods and 2 758 on services), including 11 565 complaints against an online diaper retailer engaging in wrongly accepting payment. The remaining complaints mainly involved foodstuffs, ginseng and dried seafood/pharmacy and Chinese medicines, electronic products, education, beauty and travel services, representing an increase of 2.1 times over 2022. Among them, 18 063 complaints have been processed, of which 14 892 were combined into a total of 96 cases for detailed investigation, mainly involving allegations of false trade descriptions, wrongly accepting payment and misleading omission, while the remaining 3 171 had been concluded or referred to other relevant law enforcement agencies or authorities for follow-up actions since they were not in contravention of the Trade Descriptions Ordinance.

## **Operations and Significant Cases**

Following the full resumption of normal travel between Hong Kong and the Mainland in 2023, C&ED has been concerned about visitors being misled by unfair trade practices. Through deploying the Quick Response Team to handle urgent complaints lodged by visitors and conducting test-buy operations, C&ED detected five cases that targeted Mainland visitors. The cases involved unclear pricing units of ginseng and dried seafood or Chinese herbal medicines, or the sale of passing-off items in respect of proprietary medicines. Eight persons were arrested, and all of them were found misleading customers by omitting material information such as the genuine unit price and the total price of the goods, or by claiming that the passing-off items were genuine products. Other significant cases included false claims on the weight or origin of food products, and wrongly accepting payment when selling air conditioners on the Internet.

In April 2023, a chain retailing group was convicted and fined \$35,000 for supplying and being in possession of bagged seaweed roll rice crackers to which a false trade description had been applied for the purpose of trade. A total of 9 745 packs of bagged seaweed roll rice crackers involved in the case were also confiscated.

In October 2023, a proprietor and a staff member of an online electrical appliance retailer were convicted of several counts of wrongly accepting payment in the course of selling air conditioners. Both were sentenced to 31 weeks' imprisonment, which was the heaviest penalty imposed for cases involving wrongly accepting payment.

# Revenue Collection and Protection


#### **Dutiable Commodities**

C&ED is responsible for the collection and protection of revenue on four types of dutiable goods, namely liquor, tobacco, hydrocarbon oil and methyl alcohol. Apart from duty assessment and collection, C&ED also administers a licensing and permit system to control the manufacture, import, export, storage and movement of dutiable commodities for the purpose of revenue protection.



#### Revenue

In 2023, excise duties collected amounted to \$10.7 billion, representing a decrease of 10.65 per cent when compared with 2022.





#### **Vehicle Valuation**

Through a vehicle importer/distributor registration system, market research on vehicle prices, onsite vehicle inspections, robust enforcement and various compliance promotion activities, C&ED has continued to achieve results in safeguarding collection of first registration tax and protecting the rights of buyers. In 2023, the number of vehicles first registered was 55 902, and the first registration tax collected was \$5.8 billion, representing an increase of 20.8 per cent when compared with 2022.

In 2023, C&ED prosecuted 18 vehicle dealers for contravening the Motor Vehicles (First Registration Tax) Ordinance, involving 42 vehicles. In general, under the supervision of C&ED, illegal sales continued to be kept under control, and the number of illegal cases remained at a low level.





#### **Illicit Cigarettes**

The illicit cigarette trade is a common concern of Customs administrations worldwide and combating illicit cigarette smuggling remains a high-priority task for C&ED. It is observed that large shipments of illicit cigarettes are mainly smuggled into Hong Kong via sea routes. In addition to risk-based routine inspection at entry/exit points, enhanced intelligence exchange and parallel operations with the Mainland and overseas Customs counterparts have proven to be effective enforcement strategies to suppress illicit cigarette smuggling. In 2023, a total of 552 million sticks of smuggled cigarettes were seized, the majority of which found from seaborne containers.





In January 2023, a total of about 69 million sticks of illicit cigarettes were seized in the largest illicit cigarette smuggling case detected during the year.

C&ED detected 11 806 illicit cigarette cases with seizures of 652 million sticks of cigarettes and arrests of 10 994 persons in 2023. The total value of the seized illicit cigarettes amounted to \$2,256 million and the duty potential was \$1,541 million. As compared with the preceding year, the numbers of cases and arrests increased by 243 per cent and 291 per cent respectively. Among the seizures, about 593 million sticks were related to local illicit cigarette activities, representing a decrease of about 14 per cent as compared with 2022. C&ED will continue to adopt the enforcement strategy of tackling cigarette smuggling at source to intercept the inflow of illicit cigarettes into the market.

Telephone ordering has taken over street peddling to become the predominant mode of retailing of illicit cigarettes. Two dedicated task units were established in 2012 and 2013 respectively to collect and analyse intelligence, and mount special operations to suppress these activities. The operational achievement was outstanding, with the detection of 610 cases involving the total seizure of 4.6 million sticks of illicit cigarettes and the arrest of 620 persons in 2023.

#### **Illicit Fuel**

Rigorous enforcement through increased checks on incoming vehicles and vessels has contained the problem of illicit fuel smuggling from the Mainland. In 2023, ten importation cases, five by land and five by sea, were detected with 11 300 litres of illicit fuel seized.

Illicit fuel activities continue to diminish. For diesel oil, there have been fading trends of smuggling duty-not-paid light diesel oil from the Mainland for sale in the local black market and illegal use of marked/detreated oil as vehicular fuel, following the reduction of the duty rate of Euro V diesel to zero since 14 July 2008. For illicit motor spirit, the continuous and active enforcement actions over the years have achieved the deterrent effect, resulting in a noticeable decline of such activities. Currently, only small-scale illicit motor spirit stations are being operated in a sporadic manner in remote areas of the New Territories. In 2023, 12 cases were detected with 25 300 litres of illicit motor spirit seized.

# Financial Investigation

Customs officers briefed the media on the detection of a transnational money laundering case.



# (1) Organized and Serious Crimes

A total of ten money laundering cases were detected under the Organized and Serious Crimes Ordinance (OSCO) in 2023, showing an increase of 11 per cent as compared with 2022; 56 persons were arrested, representing a year-on-year increase of 1.9 times; and the amount of money involved reached \$12.3 billion, representing an increase of 1.4 times as compared with 2022. Six cases involving over \$100 million were detected, with the largest being \$6 billion.

#### **Operation "Hornet"**

In January 2023, C&ED detected the largest-ever money laundering case of the Department with a laundered amount of \$6 billion and cracked down on a huge money laundering syndicate. Investigation revealed that the syndicate had opened a number of personal and company bank accounts in various local banks to deal with large amounts of funds from unknown sources between 2020 and 2022. Syndicate members also rented a residential flat at a large private housing estate in an attempt to camouflage the operation of money laundering activities. A total of nine persons were arrested in the enforcement action.

#### **Operation "Checkmate"**

Between May and June 2023, C&ED successfully smashed a money laundering syndicate deploying air passengers to assist in money laundering by transporting large quantities of cash into Hong Kong. After the full resumption of travel in early 2023, C&ED intensified intelligence analysis of cash declaration data collected by virtue of the Crossboundary Movement of Physical Currency and Bearer Negotiable Instruments Ordinance (Cap. 629) and found that, from January to May, there was a syndicate suspected of arranging its members to frequently transport large quantities of United States (US) banknotes from overseas into Hong Kong in the capacity of air passengers, with suspicious declarations made to C&ED. Subsequently, C&ED mounted an operation codenamed "Checkmate" in May 2023 and successfully smashed the money laundering syndicate with 23 local men being arrested for conspiracy to money laundering. The total laundered amount was about \$720 million and \$43 million of suspected crime proceeds in cash were seized.

### **Operation "Gem Crusher"**

In December 2023, C&ED successfully detected the firstever money laundering case involving transnational diamond trade with a laundered amount of \$500 million. Upon intelligence exchange with the Indian Customs authority in early 2023, Customs officers uncovered that a transnational money laundering syndicate had set up diamond trading companies in Hong Kong to export lowvalue synthetic diamonds from Hong Kong to India, but lodged false declarations as natural diamonds of high value in 2021, in a bid to exaggerate the value of the diamonds and transfer suspected crime proceeds from India to Hong Kong as "legitimate payments" for the diamonds. Together with the four syndicate members arrested by the Indian authority, a total of nine persons were arrested in Hong Kong and India.



#### **Operation "Spark"**

In October 2023, C&ED cracked down on a money service operator (MSO) using a shell company for money laundering. During the operation, four syndicate members were arrested, with a laundered amount of \$600 million. Investigation revealed that the compliance officer of the MSO had set up a shell company and opened accounts at four local banks to frequently deal with suspicious transactions of large amounts of funds for money laundering from January 2021 to July 2023.

# (2) Anti-Money Laundering and Counter-Terrorist Financing

To align Hong Kong's anti-money laundering and counter-financing of terrorism regime with the prevailing international standards, the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (AMLO) (Cap. 615) and its preceding ordinance came into operation on 1 April 2012.

#### **Supervision of Dealers in Precious Metals and Stones**

Under the AMLO, the regulatory regime for dealers in precious metals and stones (DPMS) administered by C&ED was implemented on 1 April 2023. The Department is responsible for monitoring the ongoing compliance of DPMS with the anti-money laundering and counter-terrorist financing obligations as appropriate. Registration under the regime falls into two categories:

As at 31 December 2023, a total of 6 961 registration applications (including 5 793 for Category A and 1 168 for Category B) were received, while 3 460 Category A registrations and 350 Category B registrations were approved.

### **Territory-wide Outreach Exercise and Publicity Efforts**

The nine-month transitional period ended on 31 December 2023, during which C&ED conducted a territory-wide outreach exercise to visit over 6 400 dealers and reach out to 3 400 local and 4 100 non-local exhibitors. Besides, a total of 77 seminars were arranged for 3 466 dealers in the industry in 2023

### **Establishment of the "DPMS Sector Advisory Group"**

To strengthen collaboration with various stakeholders of the industry, C&ED established the "DPMS Sector Advisory Group" in October 2023 with the appointment of 18 business leaders in the industry as non-official members for exchanging views on issues of common concerns on the implementation of the regulatory regime.

#### **Regulation of Money Service Operators**

Under the AMLO, the Commissioner of Customs and Excise is the relevant authority of both MSOs and the Postmaster General, and is responsible for the ongoing supervision of their compliance with customer due diligence and record-keeping requirements. Any non-compliance with the statutory requirements may be liable to criminal and/or civil sanctions. C&ED also spares no effort in detecting and investigating unlicensed money service operation (UMSO) and other licence-related offences.

As at 31 December 2023, there were 632 licensees on the Register of MSOs. In 2023, by way of a risk-based strategy, 98 licensed MSOs were selected for compliance inspection with 59 non-compliant cases detected. Disciplinary sanctions were initiated against 10 of the cases. C&ED would continue to take appropriate deterrent measures, including public reprimand, pecuniary penalty and remedial action orders, to deal with various non-compliances. C&ED also prosecuted persons involved in 28 UMSO cases. In one of the cases, the shop worker and proprietor of the MSO were respectively sentenced to imprisonment for seven weeks and one day and four weeks and five days, suspended for 12 months. For the remaining cases, a total of 80 hours of community service orders and a total fine of \$585,000 were imposed.

#### **Outreach Programmes and Educational Seminars**

C&ED regularly conducts training and outreach programmes for MSOs to enhance their capacity in fulfilling their obligations. In 2023, C&ED organised various seminars and small group workshops, and continued to implement territory-wide outreach programmes to help MSOs gain a better understanding of their anti-money laundering and counter-terrorist financing obligations, and raise their awareness of money laundering and terrorist financing risks. The outreach programmes also facilitated C&ED's assessment and determination of individual MSOs' risk profiles. Besides, the amended AMLO and relevant guidelines came into effect in 2023. Through seminars and outreach programmes, as well as collaboration with the Hong Kong Money Service Operators Association, C&ED provided appropriate practical guidance to the industry and explained to MSOs the latest regulatory requirements.

# (3) Cross-boundary **Movement of Physical Currency and Bearer Negotiable Instruments Ordinance**

The Ordinance came into operation on 16 July 2018. A declaration and disclosure system was established to detect the crossboundary movement of a large quantity of physical currency and bearer negotiable instruments (CBNIs) into or out of Hong Kong. **C&ED** monitors the cross-boundary transportation of CBNIs through the system to combat money laundering and terrorist financing activities.

A total of 21 451 declarations involving \$1,221.8 billion of CBNIs were received in 2023. For the traveller channel, the 81 persons who committed an offence paid a fixed penalty of \$2,000 to discharge their legal liabilities. Three cases were detected in the cargo channel and all of them were subject to criminal proceedings.

### **Smuggling of Cash through Air Parcel**

In February 2023, C&ED inspected an air parcel, declared as clothes and books, arriving from Korea at Hong Kong International Airport. Upon inspection, Customs officers found undeclared foreign currency with a total value of about HK\$1.2 million. Investigators mounted a controlled delivery operation and arrested two non-local men involved in the case in an urban area. They were charged with one count of causing to be imported a large quantity of CBNIs for which no declaration was made. Further investigation revealed that the duo had participated in cash smuggling activities on a number of occasions since December 2022. Subsequently, they were further charged with one count of money laundering offence with a laundered amount of about \$18 million.

# **Criminal Prosecution**

C&ED takes criminal prosecution seriously with the aim of bringing offenders to justice. Successful prosecution is not only an encouraging finale to frontline operations and investigations, but also serves as a strong deterrent to criminals. In 2023, the number of prosecution cases was 1 851, of which 219 (11.8 per cent) were related to the Import and Export Ordinance, 1 058 (57.2 per cent) related to the Dutiable Commodities Ordinance, 263 (14.2 per cent) related to the Trade Descriptions Ordinance, 188 (10.2 per cent) related to the Dangerous Drugs Ordinance and 38 (2.1 per cent) related to the Copyright Ordinance. A total of 1 914 persons and 170 companies were prosecuted, resulting in a total fine of \$8.99 million and the imposition of imprisonment in 264 cases.

#### **Prosecution Summary**

In 2023, a total of 1 686 persons and 167 companies were convicted in prosecution cases brought by C&ED. Details of the prosecution figures are set out in Appendices 12 to 14.

# **Effective Clearance**

C&ED plays a pivotal role in protecting the overall interests of Hong Kong and safeguarding public safety.

Customs officers are committed to combating cross-boundary illegal activities, including performing core functions like narcotics interdiction, anti-smuggling, revenue protection, strategic trade controls and protection of intellectual property rights. They are also deployed in various sea, land and air control points to conduct effective clearance checks on passengers and their baggage, cargoes, postal parcels and cross-boundary conveyances going in and out of Hong Kong. Through proactive risk management and intelligence-led law enforcement strategies, Customs officers conduct targeted anti-smuggling operations in a timely manner to curb all relevant illegal activities.

Furthermore, C&ED is dedicated to fulfilling international obligations and facilitating movement of import and export goods while protecting Hong Kong from the threat of illegal activities. As the first line of defence to safeguard Hong Kong, Customs officers strive to contribute to Hong Kong's security and prosperity by devotedly discharging their duties and fully implementing efficient import and export controls.

# **Swift recovery**

## Seize the opportunity

## Welcome to glory

Since the full resumption of normal travel, the numbers of cross-boundary passengers and vehicles have gradually increased. Customs officers remain committed to their duties to provide efficient clearance service to passengers, vehicles and cargoes entering or exiting Hong Kong and to ensure smooth operation of various control points. In 2023, the numbers of inbound and outbound passengers and vehicle trips at various control points were approximately 210 million and 10.3 million respectively, which returned to about 65% over the same period before the 2019 epidemic.

Hong Kong and the Mainland Customs maintain close contact and work exchanges with other government departments in boundary areas for better understanding of the latest developments and operation of the control points so that all cross-boundary passengers, whether daily commuters or visitors, can experience smooth and efficient Customs clearance.

During major festivals, Guangdong, Hong Kong and Macao Customs have worked closely together to make early preparation for the peak travel periods. Through a point-to-point liaison channel, real time traffic situation of the passenger and vehicular flow at various control points can be monitored to provide timely notifications and adopt response measures for smooth operation of the control points.




# Facilitating Customs Clearance

C&ED continues to promote the development of smart Customs in order to enhance its law enforcement capabilities and effectiveness.



"Smart Under Vehicle Robot" was introduced. By using Artificial Intelligence (AI) for high-definition image comparisons, contrabands hidden beneath vehicles can be detected more effectively and quickly, which will in turn enhance Customs officers' capabilities to inspect cross-boundary vehicles and detect relevant smuggling activities.





Customs officers have worked smoothly with detector dogs to detect contrabands such as drugs, firearms and explosives.



C&ED introduced the Virtual Customs Ambassadors in December 2023. Through AI, enquiries from members of the public and passengers are dealt with immediately.




# Leading the Way Connecting the Future

HK Customs has long been fully supporting and complementing the Central and the HKSAR Government to promote the development of the Guangdong-Hong Kong-Macao Greater Bay Area.

"Northbound Travel for Hong Kong Vehicles" (the Scheme)" was successfully launched on 1 July 2023. The Scheme allows eligible Hong Kong private cars to travel between Hong Kong and Guangdong via the Hong Kong-Zhuhai-Macao Bridge (HZMB) without the need to obtain regular quotas, facilitating Hong Kong residents to drive to the Mainland for business, visiting families or sight-seeing on a short-term basis. As at the end of 2023, a total of 285 000 private cars had made use of the Scheme. In December 2023, the daily average of private cars crossing the HZMB Hong Kong Port under the scheme was about 3 200, which was 39% of the daily total (about 8 200 private cars). The Scheme has greatly increased the private car throughput of HZMB, which boosts better use and management of the bridge as well as the social-economical integration of the Area.











## **Smart Collars**

# **Enhancing Canine Enforcement Effectiveness**

With diversified sniffing capabilities, Customs Detector Dogs are able to detect five kinds of controlled items namely, drug, explosive, cash, firearm and tobacco. C&ED applies the Smart Kennel Management System to analyse the health condition and biological traits of different canine, and pair dogs to ensure successful mating and breeding. Additionally, the System records training progress, analyses canine strengths and weaknesses to enhance the training effectiveness and operational efficacy of the Customs Canine Force.

In March 2023, C&ED became the first law enforcement agency to apply "Smart Collar" in the canine enforcement domain.





Smart Collars can measure the physical data of a detector dog, such as heart rate and respiratory rate, enabling the handler to instantly monitor the physical condition of his/her detector dog. The data collected by the Smart Collars will be further analysed and integrated into the Smart Kennel Management System.

# Consumer Protection



C&ED protects consumer interests through the enforcement of the Weights and Measures Ordinance, the Toys and Children's Products Safety Ordinance, the Consumer Goods Safety Ordinance, and the Trade Descriptions Ordinance.

## (1) Weights and Measures Ordinance

To eradicate the sale of short-weighted items to consumers in a dishonest way, C&ED conducted 1758 spot checks and 299 investigations in 2023 to detect and deter the use of inaccurate weighing and measuring equipment in trade and the supply of goods which were short of the purported weights. Retailers which involve relatively more complaints about short weight of goods continued to be the targets of C&ED's enforcement actions. In 2023, prosecution was taken in one case and warning letters were issued in 32 cases for contravention of the Weights and Measures Ordinance.

# (2&3) Toys and Children's Products Safety Ordinance and Consumer Goods Safety Ordinance

C&ED conducts spot checks and investigations of toys, children's products and consumer goods available in the market to ensure that they are reasonably safe and affixed with bilingual warning labels. In 2023, 3 747 spot checks and 161 investigations were conducted and 8 prosecution cases were concluded. Besides, C&ED issued 10 prohibition notices prohibiting the supply of unsafe products, such as stuffed toys, children's cots, toy gun sets, surgical face masks, smart glasses and whitening cream.

In order to step up enforcement actions, C&ED also conducted 12 blitz checks against the import of unsafe toys, children's products and consumer goods at boundary control points in 2023.




#### (4) Trade Descriptions Ordinance

The Trade Descriptions (Unfair Trade Practices) (Amendment) Ordinance 2012 (the Amendment Ordinance) came into operation on 19 July 2013. To protect the interests of consumers and honest traders, C&ED has been taking stringent enforcement actions against traders employing unfair trade practices.

#### **Special Patrol Operations**

C&ED proactively carried out 4 024 spot checks on retail stores and stalls at trade fairs/exhibitions. C&ED has established Quick Response Teams to handle urgent complaints lodged by short-term visitors and local consumers. During the year, Quick Response Teams were summoned on 201 occasions to handle urgent complaints.







C&ED officers conducted patrol at the Hong Kong Book Fair to verify whether the price of goods advertised tallies with the actual selling price and to remind traders to comply with the requirements of the Trade Descriptions Ordinance.

#### **Publicity and Education**

Apart from taking necessary and timely enforcement actions, C&ED has strived to carry out promotion and education programmes to enhance consumers' understanding of the Trade Descriptions Ordinance (TDO). In 2023, C&ED hosted a number of public education sessions in Kwun Tong, Kwai Chung, Fanling and Tai Po to raise public understanding of consumer interests and the TDO, and alerting people to consumer pitfalls.

In 2023, C&ED held a total of 34 outreach talks, seminars and meetings for various industries with the aim of enhancing practitioners' understanding of the TDO, reminding them of the importance of complying with the TDO, and urging the management to adopt appropriate measures to avoid unscrupulous trade practices.

During the first Labour Day Golden Week and National Day Golden Week following the resumption of normal travel between Hong Kong and the Mainland, C&ED launched two operations codenamed "Felicity" and "Thunder" respectively to step up patrols at popular tourist spots. Mobile promotion vehicles, booths and banners were set up to remind visitors to stay vigilant against unscrupulous trade practices for the avoidance of consumer pitfalls. In addition, C&ED posted publicity videos on social media, such as the Department's official Douyin, WeChat and Facebook accounts. Meanwhile, the videos were broadcast on cross-boundary buses and at bus stops where relevant leaflets were also displayed. The publicity programmes achieved remarkable effect and were well-received.

C&ED officers conducted high-profile patrols at popular shopping spots in various districts to remind traders to comply with the requirements of the Trade Descriptions Ordinance.

actively implements the certification and licensing systems so as to safeguard Hong Kong's trading integrity. The effective enforcement of various trade controls systems and regimes not only secures compliance with international obligations and multilateral trade agreements, but also facilitates trade and economic development.



#### **Upholding Hong Kong's Trading Integrity**

Given the importance of trade and industry to the economy of Hong Kong, C&ED enforces various trade controls systems, including the Certification of Origin System, the Strategic Trade Controls System, the Import and Export Declaration System and the Kimberley Process Certification Scheme, to discharge its international obligations and comply with multilateral trade agreements. Apart from protecting the legitimate interests of traders and manufacturers through enforcement actions, C&ED helps mediate disputes between overseas traders and local suppliers to uphold Hong Kong's trading integrity.

#### Strategic Trade Controls System

C&ED is the sole enforcement agency for strategic trade controls. The comprehensive and stringent control over the import and export of strategic commodities prevents Hong Kong from being used as a conduit for the proliferation of weapons of mass destruction, while ensuring the free flow of advanced technology for legitimate commercial, industrial and research use.

In 2023, C&ED conducted 1 398 import licence checks, 2 348 export licence checks and 585 disposal checks on strategic commodities. C&ED also mounted several special operations and stepped up enforcement by conducting blitz checks against unlicensed shipments of strategic commodities destined for sanctioned countries and other areas. As a result, four cases were detected with a total of ten pieces of strategic commodities intercepted. During the year, C&ED investigated 232 cases and prosecuted 36 persons/companies, leading to a total fine of \$430,000 and the forfeiture of goods with a value of \$1.5 million. The value of the goods involved in the prosecution cases was \$7.1 million.

## Import and Export Declarations and Cargo Manifests

C&ED administers the Import and Export Declaration and Cargo Manifests System. C&ED conducts checks to ensure that accurate, full and complete cargo manifests, and import and export/re-export declarations are submitted within the statutory time frame. Late lodgment of cargo manifests/declarations or lodgment of inaccurate cargo manifests/declarations is liable to prosecution and penalties.

C&ED received 18.42 million declarations and collected \$397 million import and export declaration charges/clothing industry training levies/late penalties in 2023. The total amount of late/administrative penalties imposed and short-paid declaration charges/clothing industry training levies recovered was \$7.69 million. In addition, C&ED received approximately 4.92 million cargo manifests in respect of different modes of transport, including air, ocean and road.

#### **Educational Seminars**

In order to reduce the number of late and non-lodgment cases, C&ED regularly conducts educational seminars to remind traders and carriers/forwarders of their obligations and to enhance their knowledge of timely lodgment of accurate trade declarations and cargo manifests. C&ED organised eight educational seminars for 118 traders and carriers/forwarders in 2023. Furthermore, C&ED will continue to collaborate closely with the Census and Statistics Department with a view to raising the awareness of timely lodgment of cargo manifests and import/export declarations.





#### Closer Economic Partnership Arrangement – Trade in Goods

Since the implementation of the Closer Economic Partnership Arrangement (CEPA) on 1 January 2004, all products of Hong Kong that fulfil the mutually agreed CEPA Rules of Origin enjoy zero tariff treatment upon importation into the Mainland if they are covered by a Certificate of Hong Kong Origin (CEPA) (CO(CEPA)). In 2023, a total of 11 693 applications for CO(CEPA) were received. Of these applications, 11 537 CO(CEPA)s with a total value of \$950 million were issued. These applications covered a wide range of products, with food and beverage, plastics and plastic articles, textiles and clothing, pharmaceutical products, and chemical products comprising the top five in terms of value.

Charged with the enforcement duties of the CEPA Certification System, C&ED conducted consignment checks against 743 applications for CO(CEPA) and examined 18 CEPA consignments at various cargo exit points in 2023.

## Kimberley Process Certification Scheme

The Kimberley Process Certification Scheme for rough diamonds requires registration of rough diamond traders and comprises a certification system for the import and export of rough diamonds. C&ED conducted 224 consignment inspections and six investigations on rough diamonds in 2023.

## Reserved Commodities Control

Through the enforcement of the Reserved Commodities Ordinance, C&ED monitors the import and export of rice to ensure a stable supply of rice in Hong Kong. In 2023, C&ED conducted 4 337 inspections, investigated 27 cases, and prosecuted four persons/companies for importing rice without a valid import licence and one company for breaching rice registration conditions, resulting in a total fine of \$22,500 in 2023. In these cases, the value of the rice involved was around \$20,056.

# Mainland Cereals and Grain Flours Control

Since 2008, the Mainland has implemented export administrative measures for cereals and grain flours, requiring that their exports are for consumption in Hong Kong only. To complement the measures, C&ED conducted 143 inspections/verifications in 2023.




#### **Trade Mediation**

To safeguard Hong Kong's trading reputation, C&ED provides free mediation service to settle trade disputes between overseas trading firms and local companies. In 2023, C&ED successfully settled nine of 17 cases it mediated.

# Trade Facilitation

In particular, it plays an important role in facilitating trade and putting in place various clearance facilitation measures, with a view to further strengthening Hong Kong's status as an international trade centre and major logistics hub in the Asia-Pacific region, which is conducive to the long-term economic development of Hong Kong.

## Intermodal Transhipment Facilitation Scheme and Single E-lock Scheme

C&ED launched the Intermodal Transhipment Facilitation Scheme (ITFS) in November 2010. Under the scheme, transhipment cargoes will normally be examined only once at either the point of entry or exit.

To further facilitate the transhipment of cargoes to and from the Mainland, C&ED and the Mainland Customs joined hands to launch the Single E-lock Scheme (SELS) in March 2016 by connecting ITFS with the Mainland Customs' Speedy Customs Clearance System with one single e-lock. The two Customs administrations monitor the cargoes based on the principle of "across the boundary with one single e-lock under separate monitoring". The green light on the e-lock is used to indicate the inspection result for the other party's reference. It thus reduces any duplicate inspection of the same shipment by both Customs administrations, saving time and cost for the industry.

In June 2023, SELS was successfully extended to Hunan Province, covering 78 clearance points in both Hong Kong and the Mainland. This provided the industry with over 820 cross-boundary route options. To further promote SELS, C&ED not only organised a joint-seminar on various Customs trade facilitation schemes in Hong Kong, but also held seminars jointly with the Mainland Customs in Zhuhai and Nanchang to introduce the latest development of SELS to the logistics industry and trade associations.

## Free Trade Agreement Transhipment Facilitation Scheme

C&ED launched the Free Trade Agreement Transhipment Facilitation Scheme (FTA Scheme) on 20 December 2015. Through the provision of Customs supervision and issuance of Certificates of Non-manipulation, the FTA Scheme facilitates the application for preferential tariff treatment under trade agreements signed between the Mainland and its trading partners for cargoes passing through Hong Kong.

The FTA Scheme currently covers 19 trade agreements and involves 67 countries/regions, of which 60 are Belt and Road economies.

## Express Route for Air-Land Fresh and Live Products

To further promote the economic development of the Guangdong-Hong Kong-Macao Greater Bay Area (GBA), C&ED is actively collaborating with the Mainland Customs and the Zhuhai Municipal Government to implement a new trade facilitation initiative known as "Air-Land Fresh Lane", which aims to leverage the geographical advantages of the Hong Kong-Zhuhai-Macao Bridge (HZMB) and the Hong Kong International Airport to build a "Green Channel" for the seamless transportation of fresh food products between the GBA and overseas markets. With the application of technology such as accredited e-locks, transportation security is ensured, and clearance procedures of the two places are streamlined.

C&ED has set up a working group with the Airport Authority Hong Kong to devise facilitation measures and explore business opportunities. Meanwhile, C&ED has been working closely with the Mainland Customs and the Centre for Food Safety of the Food and Environmental Hygiene Department to formulate streamlined clearance procedures for fresh food products of the two places.

To cater for this facilitation scheme, the Mainland Customs is building a clearance facility for fresh products within the Zhuhai Port of the HZMB. Completion of works is expected in the second half of 2024.

#### Guangdong-Hong Kong-Macao Customs Clearance Information Platform

To minimise the inconvenience and confusion caused to passengers and the transport industry due to differences in customs controls of passengers and goods, tariffs and duties on goods and facilitation measures in Guangdong, Hong Kong and Macao, the three Customs administrations agreed to jointly develop the Guangdong-Hong Kong-Macao Customs Clearance Information Platform in March 2023 in order to enhance the efficiency of passenger and cargo clearance in the GBA.

The initiative aims to provide a one-stop enquiry service for passengers and the transport industry in the three places through an Internet site and a mobile application, allowing them to obtain real-time clearance information of the three Customs administrations, which includes Customs regulations, announcements, clearance guidelines, enforcement cases, clearance situations at control points of the three places, as well as an online intelligent chatbot to answer public enquiries, with a view to facilitating passenger clearance and enhancing clearance efficiency.



#### C&ED introduced the ATCS on 30 June 2023.

#### Alternative Smoking Product Transhipment Control Scheme

C&ED implemented the Alternative Smoking Product Transhipment Control Scheme (ATCS) on 30 June 2023 subsequent to the gazettal of the Import and Export (Amendment) Ordinance 2023 on the same day. The ATCS allows intermodal transhipment of alternative smoking products (ASPs) from the Mainland to overseas markets via the Hong Kong International Airport to meet the operational needs of the logistics industry while preventing leakage of ASPs into the local market.

Participants of ATCS shall register with C&ED and follow the security and procedural requirements set out in the practice guidelines when handling intermodal transhipment of ASPs. The ASPs concerned should be consigned on a through bill of lading from a place outside Hong Kong to another place outside Hong Kong via sea-to-air or land-to-air transhipment arrangements. Prior declaration should be made to C&ED, and the ASPs should be transported and stored in a secured manner, and directly transhipped to the specified cargo handling area of the Hong Kong International Airport along a designated routing under C&ED's monitoring. Upon completion of cargo unloading, the ASPs should be transferred to the cargo transhipment area pending exportation.

As of 31 December 2023, 28 operators including 27 for land-to-air and one for sea-to-air transhipment were registered under the scheme. A total of 979 ASP consignments (2 665 tonnes) have been transhipped, involving 561 (1 399 tonnes) by sea-to-air mode and 418 (1 266 tonnes) by land-to-air mode.



C&ED organised the "AEO Expert Mission and Symposium for ASEAN and Hong Kong, China" in November 2023 with the support of ASEAN.

## Hong Kong Authorized Economic Operator Programme

To safeguard the international supply chain and facilitate global trade, C&ED launched the Hong Kong Authorized Economic Operator (AEO) Programme in 2012. The Programme allows local companies satisfying prescribed security requirements to be accredited as trusted partners, whose cargoes are eligible for reduced inspections and priority clearance at entry and exit points. Up to 2023, a total of 84 local companies were accredited as AEOs.

During the year, C&ED is striving to enhance co-operation with the Association of Southeast Asian Nations (ASEAN). With the support of ASEAN, C&ED organised the "AEO Expert Mission and Symposium for ASEAN and Hong Kong, China" in November, during which C&ED signed Action Plans for AEO Mutual Recognition Arrangement (MRA) with Customs administrations of Cambodia and the Philippines.

In addition, there has been significant progress in our work in the GBA. After ratifying the 14th MRA with the Macao Customs, C&ED signed the Memorandum of Understanding (MoU) on Enhancing AEO Co-operation in the Greater Bay Area with the Mainland and Macao Customs to bring more benefits to AEOs and foster trade development in the region.

# Development of Trade Single Window

The Trade Single Window (TSW) provides a one-stop electronic platform for the trade to lodge business-to-government import and export trade documents for trade declaration and cargo clearance. Implementation of the TSW will overhaul and enhance document submission workflows between relevant government departments and the trade to improve the efficiency of cargo clearance in Hong Kong, and consolidate Hong Kong's status as a prominent international trade centre and logistics hub. C&ED, being the TSW operator, established the Office of Trade Single Window Operation (OSWO) in 2018 to oversee the system operation and provide registration, training as well as helpdesk and hotline services to TSW users.



#### Phase 1 - Achieving notable results

The TSW is implemented in three phases. Launched in 2018, Phase 1 services, covering 14 types of trade documents, is now in full service and well received by the trade. The average monthly usage rate reached 90% as at the end of December 2023. For some licences/permits, the usage rate even reached 100%.

#### Phase 2 - Implemented ahead of schedule

Phase 2 services, covering another 28 types of trade documents, were rolled out ahead of schedule between May and December 2023. In addition to significantly expanding the coverage, Phase 2 services have enhanced system functions to create better user experience.

#### Phase 3 - Developing full steam ahead

C&ED is working closely with the Single Window Project Management Office of the Commerce and Economic Development Bureau and relevant participating government agencies on the development of the Phase 3 system, which is targeted for roll-out in batches from 2026 onwards. Phase 3 is the final and most complex phase, which will cover Import and Export Declaration, Advance Cargo Information, Cargo Manifests and Cargo Reports in respect of different transport modes, and applications for the Certificate of Origin and Permit for Dutiable Commodities. In addition, a new and highly automated cargo risk assessment engine will be built to assist C&ED to perform risk assessment of cargo data and conduct cargo selection and examination.

# Stepping up publicity to expand user base

To tie in with the roll-out of Phase 2, OSWO created a mascot called "Single Window-bot" to enhance publicity in a more effective manner. A new promotional video with "Single Window-bot" introducing the new features and benefits of TSW Phase 2 was also produced, with a view to encouraging the trade to register for the TSW as soon as possible.

In order to reach out to a wider spectrum of potential users, C&ED proactively organised large-scale seminars and collaborated with different industry associations and government departments to arrange briefings for promotion and publicity purpose.

# Co-operation with Mainland/ International Counterparts



#### **Mainland Customs**

C&ED has all along been forging stronger ties with the Mainland Customs and achieved fruitful outcomes in various aspects of co-operation. Regular review meetings and liaison meetings are convened with the General Administration of Customs of the People's Republic of China (GACC) and the Guangdong Sub-Administration of the General Administration of Customs (GSAC) to review and explore ways to further enhance co-operation. In 2000, a Customs co-operative arrangement was signed between C&ED and the GACC to actively expand and deepen collaboration, with a view to further strengthening mutual co-operation in the areas of passenger, cargo and vehicle processing, anti-smuggling, anti-narcotics, protection of intellectual property rights (IPRs) and provision of administrative assistance. In 2023, various meetings and exchange activities with the Mainland Customs were conducted. Moreover, the Co-operative Arrangement on Deepening Risk Management Co-operation and the Cooperative Arrangement on Smart Customs Development were signed with the GACC in February and November respectively; the Co-operative Arrangement on Exchange and Co-operation was signed with the Shanghai Customs College (SCC) in September; and the Memorandum of Understanding (MoU) on Enhancing Authorized Economic Operator (AEO) Co-operation in the Greater Bay Area among Mainland, Hong Kong and Macao Customs was signed with the GACC and the Macao Customs Service (MCS) in November.

#### Macao Customs Service

C&ED has been working hand in hand with the MCS over the years in the areas of revenue protection, anti-narcotics, anti-smuggling, protection of IPRs as well as training and intelligence exchange. Both administrations also endeavour to seize our country's development opportunities in the Guangdong-Hong Kong-Macao Greater Bay Area. Regular liaison meetings and annual meetings are convened with a view to strengthening co-operation between the two Customs administrations. In 2023, various meetings and exchange activities with the MCS were conducted. Moreover, the Co-operative and Mutual Assistance Arrangement and the AEO Mutual Recognition Arrangement (MRA) were signed, and the MoU on Enhancing AEO Co-operation in the Greater Bay Area among Mainland, Hong Kong and Macao Customs was also signed by both administrations with the GACC in November.

#### **World Customs Organization**

Established in Brussels in 1952, the World Customs Organization (WCO) is dedicated to the simplification and harmonisation of Customs systems and procedures, advancement of Customs techniques, improvement of Customs operations and promotion of co-operation among members to facilitate international trade. C&ED has been actively participating in various WCO meetings, including the 24th WCO Asia/Pacific (A/P) Regional Heads of Customs Administrations Conference held in Perth, Australia in May 2023, the 141st/142nd Customs Co-operation Council Sessions of the WCO held in Brussels, Belgium in June 2023, and the 33rd WCO A/P Regional Contact Points Meeting held in Melbourne, Australia in October 2023, to promote mutual assistance and co-operation among members of the A/P region and to outline the vision and aspiration of C&ED as the WCO Vice-Chairperson for the A/P Region for 2024 – 26.

#### WCO Vice-Chairperson for the A/P Region (2024–26)

In May 2023, C&ED, in the name of Hong Kong, China, was unanimously nominated as the next WCO Vice-Chairperson for the A/P Region (2024–26). Once the nomination is confirmed, C&ED has assumed the position in July 2024 for a term of two years until June 2026. Given that Hong Kong has a high degree of connectivity globally with the rest of the world and domestically with Mainland China, taking up a pivotal role in intergovernmental organisations like WCO presents a valuable opportunity for C&ED to further enhance Hong Kong's international image and reinforce global and regional partners' confidence in Hong Kong. Besides, through the pivotal role in WCO, C&ED can assist in safeguarding multilateralism and promoting international co-operation; enhancing effectiveness in regional law enforcement; and strengthening the Department's capability through proposing agenda and collaboration, which would contribute to not only Hong Kong but also the entire region.

Besides, the HKSAR Government concluded a legally binding Customs Cooperation Agreement with the European Community (now known as the European Union (EU)) in 1999 to enhance co-operation between the Department and the Customs administrations of the EU member states.

To support INTERPOL in assisting its 196 members to curb international trafficking of illicit goods and dismantle organised syndicates, and to expand C&ED's co-operation network with overseas law enforcement agencies in combating smuggling activities and transnational intellectual property (IP) crimes, C&ED has seconded officers to INTERPOL's General Secretariat at Lyon of France.

In May 2023, the Intellectual Property Investigation Bureau (IPIB), through INTERPOL's co-ordination, was invited to attend an operational meeting on anti-counterfeit electronic products organised by EUROPOL in Prague, the Czech Republic. By participating in the meeting, C&ED not only shared its achievements in transnational IPR enforcement with overseas law enforcement officers, but also strengthened our post-pandemic collaboration with overseas counterparts. In September 2023, IPIB officers attended the 16th International Law Enforcement IP Crime Conference in Oslo, Norway to enhance collaboration with IP stakeholders in combating transnational and online IPR infringement activities. In November 2023, IPIB officers attended the 20th WCO Counterfeiting and Piracy Group Meeting and a side-meeting with WCO in Brussels, Belgium to exchange views with the WCO and its members on IPR enforcement strategies and measures, and explore various initiatives to strengthen collaboration.

# The 21st Meeting of Heads of World Customs Organisation Asia/Pacific Regional Training Centres

The Hong Kong Customs College, as one of the Asia/Pacific Regional Training Centres (RTCs) of the WCO, participated in the 21st Meeting of Heads of the WCO RTCs held in Japan from 14 to 16 November 2023.

The meeting provided a platform for the Heads of RTCs to exchange views on WCO's up-to-date regional training and development policies and strategies, and share good practices in Customs training. C&ED's representative gave a presentation on the experience in the continuous enhancement of training professionalism and the nurturing of a new Customs generation, and highlighted the training programmes accredited under the Hong Kong Qualifications Framework (i.e. Induction Courses and Passenger/Cargo Processing Courses), training tools encompassing innovation and technological advancement (e.g. CAVE automatic virtual environment) and various secondment programmes designed to broaden officers' horizons.


#### Information Systems Strategy Study (ISSS)

C&ED conducted the Information Systems Strategy Study (ISSS) between 2019 and 2020, with the aim of formulating a holistic and up-to-date IT strategic plan for the coming decade and beyond. According to the ISSS's findings, C&ED can optimise the use of I&T, such as cloud computing, big data analytics and artificial intelligence (AI), to achieve digital transformation and ultimately evolve into a data-driven organisation.

Based on the recommendations of the ISSS, C&ED is proactively preparing for the building of the "Smart Customs Information Technology Infrastructure" which comprises the cloud infrastructure, "Customs Big Data Application System" and IT security enhancement. The project, targeted to be fully commissioned in 2026, echoes the national strategy of promoting technological advancement. By leveraging innovative and revolutionary technologies, such as cloud computing, big data analytics, machine learning, natural language processing and video analytics, the project enables C&ED to address operational needs and integrate into the rapidly evolving I&T landscape.

#### **Application of Innovation and Technology**

The "Smart Customs Interactive Response System" combines the application of AI technology, natural language processing and machine learning. Through the "Virtual Customs Ambassador – XiaoHui", the system can handle enquiries on our work and provide information on control points for members of the public in real time. XiaoHui is now providing service on the Customs website and at the Hong Kong International Airport, the Heung Yuen Wai Control Point, the Hong Kong-Zhuhai-Macao Bridge Hong Kong Port and the West Kowloon Station of the Guangzhou-Shenzhen-Hong Kong Express Rail Link. C&ED is planning to extend the service to other control points as well as various social media platforms so as to bring convenience to more travellers from the Mainland and around the world.





## Information Systems in Trade Facilitation and Customs Enforcement


C&ED is committed to promoting e-commerce via the construction of electronic platforms that facilitate submission of trade information and application for specific licences. In this regard, the "Trade Single Window", the "Road Cargo System" (ROCARS), the "Air Cargo Clearance System" (ACCS), the "Motor Vehicles First Registration Tax System", the "Money Service Operators Licensing System", the "Dutiable Commodities System", the "Currency and Bearer Negotiable Instruments Declaration System" and the "Dealers in Precious Metals and Stones Registration System" have been set up to provide service to the public. Newly developed IT systems have also been linked up to the "iAM Smart" platform, enabling users to log in to online services with a single digital identity and enjoy a brand new experience.

To tie in with the rapid development of the e-commerce industry, C&ED has been enhancing its electronic platforms to handle the ever-increasing amount of Customs clearance work. On 1 February 2024, C&ED launched the Guangdong-Hong Kong "Single Submission for Dual Declaration" Scheme on cargo, which allows traders to enjoy the benefits of interconnectivity between the Mainland and Hong Kong. The scheme is a trade facilitation measure built on the China (Guangdong) International Trade Single Window Cargo Declaration System (Guangdong Platform) and the ROCARS (Hong Kong Platform). It facilitates Customs declarations for both the Mainland and Hong Kong sides by a single submission of cargo information. Export cargo information declared by Mainland enterprises through the Guangdong Platform would be encrypted and sent to the Hong Kong Platform, from which Hong Kong importers could retrieve the relevant cargo information for completion of local Customs declaration.



Being the major information systems in facilitating the clearance of intermodal transhipment cargoes, ACCS and ROCARS have been enhanced to effectively regulate alternative smoking products (ASPs) imported under the Alternative Smoking Product Transhipment Control Scheme (ATCS). New features such as ATCS registration process and connecting flight information have been added to the information systems to bring convenience to registered operators under the scheme and to tighten the control of ASP transhipment, thereby securing Hong Kong's position as an international trade centre.

Furthermore, to dovetail with the pilot run of the Cross-boundary Express Cargo Clearance Facilitation Arrangement (CEFA) in April 2024, ACCS and ROCARS were also enhanced to facilitate advance cargo information submission by the participating express cargo operators for risk assessment. Under the Scheme, qualified express cargo operators are provided with on-site Customs clearance service at designated locations in the city, thus reducing the time required for unloading, searching the express cargo for Customs action and loading the goods vehicles at land boundary control points.



# Provision of New Information Technology Facilities

To support C&ED's future operation, new IT facilities will be provided at the expanded SkyPier Terminal, the DHL Central Asia Hub Expansion, the Transit Mail Centre and the Three-Runway System. The above facilities are scheduled for commissioning between 2024 and 2026.

To facilitate travellers' declaration and disclosure of the possession of a large quantity of currency and bearer negotiable instruments (CBNIs), C&ED is developing a new electronic platform for advance submission of CBNIs information. Instead of filling in paper forms on the spot, travellers can save time by submitting CBNIs information through the electronic platform prior to their arrival in/departure from Hong Kong and present the QR codes or reference numbers generated by the system to Customs officers at control points. With the introduction of new technology and procedures, the processing time of CBNIs declaration will be shortened and travellers can enjoy better clearance experience.



Electronic platform for CBNIs declaration


#### **Computer Forensic Laboratory**

C&ED has set up the Computer Forensic Laboratory (CFL) and the Computer Analysis and Response Team (CART) to assist frontline investigators in the analysis and restoration of digital evidence, and to provide evidence for prosecution in court.

During the year, the CFL and CART continued to assist frontline officers in combating advanced technology crime and cybercrime. For example, following the implementation of the Copyright (Amendment) Ordinance 2022 on 1 May 2023, the CFL has provided technical support to investigation officers to extract relevant digital evidence from seized illicit streaming devices. The CFL also provided training workshops to investigation officers to offer them hands-on experience in seizing cryptocurrency suspected to be crime proceeds. To enhance the skills and expertise in digital forensics, the CFL sent officers to sit for examinations. They eventually became the first batch of Customs officers to obtain the "Digital Forensics Examination Techniques Accreditation" awarded by the Ministry of Human Resources and Social Security of the People's Republic of China.

Since its establishment, the CFL has processed 1 542 cases involving infringement of intellectual property rights, internet piracy, money laundering, drug trafficking, smuggling, false trade descriptions and revenue frauds.

# Advanced Training Technology

#### **Chinese-style Foot Drill Training Application**

To improve training effectiveness and keep abreast of the rapidly evolving digital world, the Office of Training and Development (OTD) and the Department of Computing of the Hong Kong Polytechnic University jointly initiated a training project on the development of an interactive training kiosk on Chinese-style foot drill which incorporated the technologies of motion detection, vision analytics and machine learning. Apart from enriching the training experience of new recruits and deepening their understanding of Chinese-style foot drill, the training kiosk also serves to enhance the sense of national identity by promoting Chinese-style foot drill.

# The Immersive Cave Automatic Virtual Environment System

OTD implemented the innovative learning tool "Cave Automatic Virtual Environment" (CAVE) in the first quarter of 2023. By leveraging the latest technologies, such as Virtual Reality (VR), CAVE helps trainees learn abstract ideas and practical skills from veterans in performing frontline duties, hence deepening their impression. It also enables them to experience investigation work at complex crime scenes, and understand various concealment methods and smuggling scenarios in a controlled and virtual environment before performing actual duties.




# The "VR Assisted Training for Inspection of Imported Goods"

In December 2022, the WCO Asia/Pacific Regional Training Centre – Hong Kong installed a VR training set, which included a headset, a controller, a high-end computer, a TV screen and a kiosk. The VR training set, developed by the WCO Virtual Reality Training Programme at the WCO Headquarters with the support of the Customs Cooperation Fund Korea, is designed to assist Customs officers around the world in learning through VR technology the basic procedures for conducting physical inspection of containerised cargo at maritime ports.

# 10 Projects



**EVER** since 2019, along the path of Hong Kong's "Smart City" development, C&ED has promulgated the "Smart Customs Blueprint" by constructing four key pillars, namely the "Smart Boundary Management", "Smart Investigation and Case Management", "Smart Trade Facilitation" and "Smart Business Development" so as to tie in with the development of the "Guangdong-Hong Kong-Macao Greater Bay Area (GBA)" and "the Belt and Road Initiative".

### I. Smart Customs Blueprint

Under the Blueprint, C&ED focused on the development of advanced equipment for Customs clearance, big data and artificial intelligence (AI) analysis and reinforcement of interconnection to strengthen its role as "law enforcer and service provider" and "trade facilitator" and shoulder a diversified role by becoming an "economic development promoter" and maintaining Hong Kong's status as a "safe city", "business city" and "investment city". To date, C&ED has implemented and been actively developing a series of smart initiatives.

Moreover, since the General Administration of Customs of the People's Republic of China (GACC) has launched the Smart Customs Initiative, with smart construction as core of the initiative, C&ED has shown full support and brought the Smart Customs Blueprint in line with the GACC's Initiative. The Department has invested substantially in developing technology such as AI, block chain, cloud computing and big data analytics to achieve integrated smart customs through innovation and technology.

In November 2023, C&ED signed the Co-operative Arrangement on Smart Customs Development with the GACC to lay a solid foundation for mutual co-operation with smart construction as the core. The integration of Smart Customs not only helps expand the scope of cross-boundary collaboration between both Customs administrations, it also facilitates the enhancement of governance systems and the governance of C&ED, and serves as a major key for C&ED in fostering the development of the Guangdong-Hong Kong-Macao GBA. C&ED will continue to deepen the exchanges and co-operation with the GACC.

#### (1) Advanced Equipment for Customs Clearance


C&ED kept introducing advanced inspection equipment, for instance, Computed Tomography (CT) Scanner with artificial intelligence function to provide 360-degree scanned images with no blind spots and automatic recognition of dangerous drugs and other contrabands; Auto-detection Device for existing X-ray checker with AI functions embedded to assist in screening for suspicious objects and automatic detection of various contrabands, such as firearms and ammunition, gun parts and weapons. Besides, C&ED also used the Smart Under Vehicle Robot, which applies AI to conduct contraband detection by comparison of under-vehicle images and thus enhance the capability in combating smuggling activities of cross-boundary vehicles. These advanced inspection equipment could greatly facilitate the clearance efficiency and enhance the ability in combating smuggling and other customs-related offence.








Meanwhile, smart initiatives to enhance the services provided to travellers and the trades at and beyond control points will be rolled out in phases. In respect of cargoes, C&ED introduced the Air Cargo Clearance Queuing System, which enabled cargo agents of the logistics sector to queue up for collection of cargoes by using mobile devices to minimise the waiting time. C&ED also completed a feasibility study on the Single E-lock Scheme 2.0 and kick-started the procurement of the relevant system for enhancement of the security and compatibility of the E-lock with a view to accelerating the flow of transhipment cargoes within the GBA. As regards passengers, an interactive response system, which includes the introduction of Virtual Customs Ambassadors at control points and an online chatbot on the Customs website, has been developed to provide instant, accurate and consistent responses to public enquiries. The whole system was put in place in December 2023.



#### (2) Big Data and Artificial Intelligence Analysis

Starting from 2020, C&ED has introduced sophisticated analytics systems in phases, including the Platform for X-ray Image Evaluation, Vehicle Inspection and Strategic Analysis System, Cargo Big Data System and Smart Liquor Duty Assessment to aid risk profiling on passenger, cargo and vehicle clearance at control points for enhancing clearance efficiency as well as strengthening detection of cross-boundary contrabands. Moreover, to ensure consumer safety and public health, C&ED has introduced a portable Non-contact Healthcare Multimeter which can quickly test the types and concentrations of alcohol content of alcoholic disinfection products and determine whether they contain methanol.









Building on the success of the Intellectual Property Rights (IPR) Big Data Analytics System for combating IPR crimes, C&ED continues to expand the system to cover other offences enforced by the Department with a view to developing the Customs Crime Analytics System (CCAS). C&ED completed the Proof-of-Concept (PoC) study of CCAS and an all-in-one database is under development. C&ED also completed the PoC study of the Smart Seizure Management System, aiming at better rationalising the control and security of seizures during deposit, storage and retrieval stages, with the application of modern technologies.

# (3) Reinforcement of Interconnection

C&ED has introduced an online self-assessment tool, namely Authorized Economic Operator (AEO) iPASS to facilitate selfunderstanding of C&ED's certifying standards and initial selfassessment by companies that are interested in joining the Hong Kong AEO Programme. To further enhance supply chain security and user friendliness of Customs clearance, connection with the Customs administrations of other economic entities through an AEO data exchange platform (APEX) was established. Automated exchange of AEO data with the Mainland Customs through this platform was implemented in order to allow AEOs to enjoy faster clearance service by more efficient, secure and timely transmission of AEO data between the two places. Besides, C&ED has collaborated with the Hong Kong Export Credit Insurance Corporation to provide Hong Kong AEOs with 10 free buyers' credit checks starting from 1 August 2023, which will assist them in coping with the market risk while expanding their business.



# II. New Control Points and Infrastructural Projects

Infrastructural projects are in the pipeline to support Hong Kong's continued economic development and to cope with the increasing cross-boundary traffic.

#### (1) Three-Runway System

To meet future air traffic growth and maintain Hong Kong's competitiveness as an international aviation hub, the Airport Authority Hong Kong (AAHK) is working full steam ahead with the Hong Kong International Airport (HKIA) Three-Runway System (3RS) project as scheduled, with the target of commissioning at the end of 2024. The AAHK will open relevant passenger facilities in phases in light of passenger traffic demand.

Commenced in August 2016, the construction of 3RS comprises different components, including construction of the Third Runway, taxiways and aprons; expansion of Terminal 2 and construction of the Terminal 2 Concourse to accommodate more arriving and departing passengers; and installation of a new automated people mover system and a high-speed baggage handling system connecting Terminal 2 with the Terminal 2 Concourse. The HKIA is expected to be able to meet the target of handling 120 million passengers and 10 million tonnes of cargo annually from 2035 onwards.








#### (2) SkyPier Terminal (formally named as Intermodal Transfer Terminal)

The AAHK developed the SkyPier Terminal to meet the anticipated demand from additional transfer passengers at the HKIA following the opening of the Hong Kong-Zhuhai-Macao Bridge (HZMB).

The development works of the SkyPier Terminal includes expansion and modification of the SkyPier and a bonded road linking to the Hong Kong Boundary Crossing Facilities of HZMB. The SkyPier Terminal commenced operation on 30 August 2023.

#### (3) Redevelopment of Huanggang Port

The building at the Huanggang Port, situated in Shenzhen, will be redeveloped in-situ. Targeted to be completed by the end of 2025, the new Huanggang Port Building will be a multi-storey building, in which customs, immigration and quarantine clearance facilities and public transport interchanges for the Mainland and Hong Kong will be set up on different floors, laying the foundation for implementing co-location arrangement at the new port to facilitate passenger clearance and enhance clearance efficiency.

#### (4) Intermodal Air Cargo Handling Facility

The Chief Executive announced in his 2022 Policy Address that the Government would reinforce intermodal transport by integrating air, sea and land transport to strengthen the key role played by Hong Kong in the logistics chain of the GBA. The AAHK has set up the "Hong Kong International Airport Dongguan Logistics Park" in Dongguan and the "Airside Intermodal Air Cargo Handling Facility" at the HKIA to facilitate sea-air cargo transhipment between Hong Kong and the GBA. C&ED provides one-stop Customs clearance service for cargoes and applies technology to manage smuggling risks and reduce the need for cargo inspection, thereby expediting the cross-boundary flow of transhipment cargoes and upholding Hong Kong's role as a logistics hub.

# Human Resources Development



THE Administration and Human Resource Development Branch is responsible for organising and co-ordinating training and development programmes for members of the Customs and Excise Service and of the Trade Controls Officer Grade to enhance their awareness of national security and integrity, and promote welfare and occupational safety and health related issues. To equip Customs officers with advanced professional knowledge and skills for continuous career development, C&ED makes significant efforts in staff training and development by adopting a competency-based strategy, supplemented by personal development programmes for individual staff.

### Foundation Learning and Development

Human resources are the most valuable assets in an organisation. To allow new recruits a firm grasp of practical work knowledge and skills, the Hong Kong Customs College (HKCC) has been providing high quality foundation training by proactively upgrading instructors' qualifications, teaching facilities and materials, and course syllabuses.

In addition to the Constitution, the Basic Law, the Hong Kong National Security Law, Laws of Hong Kong, Chinese-style foot drill, discipline and integrity, a diverse mix of knowledge (e.g. Chinese history, national education, import and export trade practices, leadership, use of force and Putonghua) has been incorporated into the induction training for both newly recruited Inspectors and Customs Officers. To familiarise trainees with their working environment, practical training with simulated and interactive exercises have been introduced. Since 2023, a study visit to the Shanghai Customs College (SCC) was arranged for Inspector inductees to foster their connection with the Motherland and deepen their understanding of the development in the Mainland.

HKCC passed the professional assessment by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications for accreditation of the Passenger Processing Course and Cargo Processing Course at Qualifications Framework (QF) Level 4 (the same QF level as a local Associate Degree or a Higher Diploma). Besides, HKCC also passed the re-accreditation of the Inspector Induction Course at QF Level 5 (the same QF level as a local Bachelor's Degree) and the Customs Officer Induction Course at QF level 4. All four courses were granted the longest validity period of four years. In 2023, 92 probationers were awarded the "Professional Certificate in Customs Control and Enforcement (Cargo Clearance)" and 89 probationers were awarded the "Professional Certificate in Customs Control and Enforcement (Cargo Clearance)". Meanwhile, 123 Probationary Inspectors and 173 Probationary Customs Officers joined the Inspector Induction Course and the Customs Officer Induction Course respectively in 2023, and were awarded the "Professional Diploma in Customs Operations for Customs Officers" respectively.



HKCC has been collaborating with the Hong Kong Metropolitan University (formerly known as the Open University of Hong Kong) (the HKMU) to strengthen enforcement training of the Inspector Induction Course and the Customs Officer Induction Course, and provide articulation pathways for the graduates. Apart from concepts of criminology, sociology and psychology delivered by university lecturers, the enhanced training also covers knowledge in conflict management, media relations, etc. Graduates will be awarded the "Certificate in Law Enforcement and Customs Management" by the HKMU, and are entitled to credit exemptions when pursuing relevant programmes offered by the HKMU in the future.

C&ED attaches great importance to professionalism of all grades of law enforcement staff and strives to provide them with quality training. The Assistant Trade Controls Officer Induction Course (ATCOIC) aims at imparting the required fundamental knowledge of a newly recruited Assistant Trade Controls Officer (ATCO), the essential practical knowledge of an officer of the Trade Controls Branch to discharge duties, and the knowledge about conduct, discipline and personal development. Since October 2020, the ATCOIC has been accredited as a QF Level 5 programme. It is the first ever civilian law enforcement induction course accredited at QF Level 5. In 2023, 36 Probationary ATCOs joined the ATCOIC and were awarded the "Professional Diploma in Trade Controls for Assistant Trade Controls Officer" at QF Level 5 in 2024.


# HKCC Professional Development Training Block



## **Personal Development of Staff**

C&ED adopts a schematic approach in training senior and middle managers. In 2023, six senior officers were sent to attend leadership development programme organised by the Civil Service College (CSC). To further enhance the leadership and management competence of the managers, and foster exchanges and co-operation with Macao law enforcement agencies, two officers from the Macao Customs and the Polícia Judiciária were invited for the first time to attend the Customs Management Development Course (CMDC) organised by the Department with 14 C&ED senior officers. Besides, the Office of Training and Development (OTD) organised a Customs Command Course (CCC), which aimed to enhance officers' skills and knowledge of work planning and modern management. A total of 22 officers participated in the course.

To strengthen middle managers' national identity awareness and professional knowledge of politics, economics, public administration and public policies, C&ED sent four officers to attend a 2.5-year part-time Executive Master of Public Administration Programme organised by the Tsinghua University and one officer to attend a two-year Master Degree in Public Policy Programme organised by the Peking University in 2023.

C&ED is dedicated to enhancing Service members' enforcement knowledge and providing them with articulation pathways for Bachelor's Degree Programmes. HKCC collaborates with the HKMU to launch a one-year part-time Bridging Course, "Certificate in Law Enforcement and Customs Management". A total of 22 Customs officers graduated from the course in 2023. Upon completion of the course, officers will be entitled to credit exemptions when pursuing the "Bachelor of Social Sciences in Law Enforcement and Security Management" (or with Honours) in the future.

C&ED has also collaborated with the Hong Kong Police Force (HKPF) and arranged officers to attend the Standard Criminal Investigation Course and the Criminal Intelligence Analysis Training organised by the HKPF. The courses aim to equip participants with the knowledge and skills required for criminal investigation and criminal intelligence analysis. In 2023, a total of 12 officers took the courses.

# Continuous Learning and Development

C&ED adopts a multi-pronged approach in promoting continuous learning and development in order to meet the ever-changing enforcement environment and rising public expectations. In addition to conventional classroom training, individual officers may study e-Learning programmes at their own pace through the Customs Portal for self-learning.

C&ED also collaborates with the CSC to deliver 66 e-Learning programmes through the Cyber Learning Centre Plus, encompassing topics related to operational skills, communication, legal knowledge, integrity, constitution and national security.

To encourage continuous learning, C&ED sponsors officers to pursue part-time Master Degree Programmes related to criminology, public administration and big data analytics. As a driving force for continuous development, C&ED holds annual Promotion Qualifying Examinations for Inspectors and Customs Officers to maintain their professionalism.



Customs officers often face unpredictable risks and challenges in carrying out enforcement duties. OTD provides frontline officers with a range of specialised training courses which aim to enhance their safety awareness, strengthen their ability to handle various threats, and bolster their search and arrest techniques. Besides, OTD also offers various courses to train officers in investigation and operational planning skills in order to combat organised crime.

# **Criminal Prosecution Training**

To ensure successful prosecution of criminal cases, the Service Prosecution Group organised a considerable number of training courses and sharing sessions on prosecution-related matters for frontline officers, including court procedures and trial preparation, court attendance and case handling, prosecution and forfeiture procedures, mock trials, etc. in an effort to keep frontline officers abreast of the latest legal knowledge and court requirements.

# Co-operation with the General Administration of Customs of the People's Republic of China

C&ED has been maintaining close co-operation in training and exchanges with the SCC, a full-time undergraduate institution directly affiliated with the General Administration of Customs of the People's Republic of China. C&ED has arranged officers to attend customs training at the SCC since 1999 and signed the "Co-operative Arrangement on Exchange and Co-operation between the SCC and the HKCC" in September 2023 to enhance exchanges and co-operation between the two colleges in areas of customs training and academic research.

## **National Affairs and National Security**

C&ED is committed to nurturing talents with a strong sense of national identity and international perspectives. In March 2023, Inspector inductees were arranged to attend the National Studies and Mainland Customs Operations Course in the SCC for the first time, thereby deepening their understanding of national security, national affairs, Mainland Customs operation and its latest developments. The arrangement has been regularised to become part of the Inspector Induction course.

Meanwhile, C&ED strives to enhance national affairs education through different initiatives. In 2023, 72 officers attended various national studies courses organised by the Police Liaison Department of the Liaison Office of the Central People's Government in the HKSAR and the CSC respectively with a view to strengthening their sense of patriotism. C&ED also launched a series of thematic departmental seminars on national security and national affairs for the first time to provide officers with a more thorough understanding of national security, history and culture, as well as the Yan'an Spirit.

In April 2023, representatives from C&ED joined the Hong Kong Disciplined Services Cultural Exchange Delegation to Beijing, Shanghai and the Greater Bay Area and visited the latest national infrastructure, witnessing the rapid development of our country in the new era. The delegation of C&ED also exchanged views with the Mainland counterparts, building a solid foundation for future co-operation.

Through diversified training and learning resources such as exchanges with the Mainland counterparts, departmental seminars, online learning pages and the National Security Education Section, C&ED reinforces all officers' understanding of the Constitution, the Basic Law, the Hong Kong National Security Law, the National Flag and National Emblem Ordinance, the National Anthem Ordinance, national affairs and a Holistic Approach to National Security in a comprehensive manner.

Officers who attended the National Studies Course held in the China Executive Leadership Academy of Yan'an shared the essence of Yan'an Spirit with colleagues during Departmental Seminar.

## **Promotion of Staff Integrity**

C&ED is dedicated to maintaining a responsible and reliable workforce. A number of educational and promotional activities on staff integrity and healthy lifestyle has been held to enhance professionalism of staff and fortify a culture of probity.

In response to the "Prudent Financial Management" training theme promoted by the Civil Service Bureau under the "Ethical Leadership Programme", C&ED has rolled out a number of educational and publicity initiatives. For instance, since August 2023, the Integrity Management Group has collaborated with the Tung Wah Group of Hospitals Healthy Budgeting Family Debt Counselling Centre and the Caritas Family Crisis Line and Education Centre to provide a 24hour hotline to support staff facing financial stress. Besides, a representative of the Investor and Financial Education Council was invited to share the best practices in financial management with officers as a guest speaker in a departmental seminar.



Dr Mike HUI, the representative of the Investor and Financial Education Council, shared the "Dos and Don'ts on Financial Management" in a departmental seminar held in November 2023.



To further improve the effectiveness of integrity management training, integrity training has been tailored for officers receiving induction, in-service and leadership training courses to deepen their law-abiding awareness and enable them to gain an understanding of their roles and responsibilities earlier. Besides, the training courses emphasise the accountability of supervisors who are required to set an example in implementing the integrity management strategy of the Department.



# Promotion of Healthy Lifestyle

# (1) Promotion of Occupational Safety and Health

C&ED has been making strenuous efforts to ensure workplace safety and raise staff awareness of occupational safety and health (OSH). The Occupational Safety and Health Steering Committee, chaired by Assistant Commissioner (Administration and Human Resource Development), formulates policies in respect of OSH in the Department. In addition, an Occupational Safety Working Group and a Health and Welfare Working Group have been set up under the auspices of the Steering Committee to co-ordinate the promotion of occupational safety and the implementation of work safety measures, and to promote occupational health and strengthen the provision of welfare assistance. In 2023, the Occupational Safety Working Group of C&ED continued to take actions on multiple fronts to meet the said objectives, in particular by paying visits to workplaces of the Department periodically for occupational safety inspection and assisting various formations in reviewing and formulating in-house safety guidelines.

The efforts made by the Ports and Maritime Command (PMC) Safety and Health Committee in strengthening co-operation between the management and frontline staff, and in promoting, developing and carrying out measures to ensure OSH of all officers are particularly noteworthy. The Committee organised the "PMC OSH Quiz Competition 2024" in March 2024 to enhance safety awareness of the formation staff.


#### (2) Welfare, Sports and Recreation

As social activities resumed to full normalcy in 2023, the C&ED Sports and Recreation Club has gradually organised various kinds of sports and recreation activities for all C&ED staff.

To give closer attention to staff welfare needs and to promote a caring culture among colleagues, C&ED has established a health and welfare management system. In 2023, almost 110 officers were appointed as Health and Welfare Managers in various offices. These officers were provided with job-related training and access to the welfare-related information system to perform their duties properly. In addition to conducting periodic welfare visits, they acted as contact points for officers in need of assistance in matters related to welfare, health and work.

Apart from in-house assistance, C&ED also commissioned the Christian Family Service Centre (CFSC) to provide counselling service for individual officers and their family members, including the provision of a 24-hour counselling and consultation hotline and face-to-face counselling by professional social workers. CFSC and other non-governmental social welfare organisations also provided training sessions to Health and Welfare Managers as well as colleagues in different formations on subjects such as mental health, first aid, the handling of pathological gamblers, counselling skills and knowledge, etc. Besides, since August 2023, the Integrity Management Group has collaborated with the Tung Wah Group of Hospitals Healthy Budgeting Family Debt Counselling Centre and the Caritas Family Crisis Line and Education Centre to provide a 24-hour hotline to support staff facing financial stress.

## Integrated Health and Exercise Programme

In the light of the new normalcy of sports and physical training, C&ED has implemented the "Integrated Health and Exercise Programme" (I-HEP) since 1 June 2023. I-HEP aims to maintain officers' health and enhance their fitness through a holistic and integrated approach and replace the requirement of the Annual Physical Fitness Test. It encompasses multiple aspects for fostering a culture of fitness and encouraging officers to incorporate exercise into their daily lives. The Working Group on Promotion of Healthy Lifestyle and Staff Integrity under the Integrity Steering Committee monitors the progress of I-HEP and makes recommendations where necessary.

Clinched a number of awards, they demonstrated their outstanding athletic prowess and skills in track and field, basketball, volleyball, football, swimming, and halfmarathon. As members of a professional disciplinary force, officers always face various challenges and uncertainties. In order to encourage them to maintain fitness to cope with the heavy workload, the Department urges them to participate in various sports activities and actively promotes a healthy lifestyle among them.

# Administration and Finance

THE Office of Departmental Administration of the Administration and Human Resource Development Branch is responsible for the general administration, personnel management, establishment control and provision of translation service whilst the Office of Financial Administration performs the functions of finance management, supplies, stores as well as management of seizures.



## **Administration**

C&ED had the following major establishment changes in 2023 -

#### **Setting up of the Customs Financial Investigation Bureau**

The Customs Financial Investigation Bureau (CFIB) was established under the Intelligence and Investigation Branch on 1 August 2023 to strengthen the capabilities of the Department to combat money laundering and terrorist financing. The establishment of CFIB involves 91 posts.





A Special Duties Team was set up under CFIB on 1 August 2023.

#### **Finance**

#### Revenue

C&ED collected \$11.42 billion of revenue in 2023-24, representing a decrease of 8.5% over that in 2022-23. This is mainly due to the decrease in revenue collection from hydrocarbon oils and tobacco.

A summary of the total revenue collected in 2022-23 and 2023-24 is at Appendix 7.

#### **Expenditure**

The total expenditure of C&ED in 2023-24 was \$5.727 billion, representing an increase of 4.7% over that in 2022-23. This is mainly due to the increase of personal emoluments arising from civil service pay adjustment and increase in other operating expenses.

A summary of the total expenditure in 2022-23 and 2023-24 is at Appendix 8.



#### Seizure Management

The provision of service for the storage and disposal of seized goods is one of the major tasks of C&ED. In 2023-24, the total average space available for storage of seized goods and vehicles in government storehouses was 57 084 square metres while that in private godowns was 12 874 cubic metres.

Upon completion of all legal proceedings concerning the confiscated goods, C&ED will dispose of the goods in accordance with the Stores and Procurement Regulations. The disposal means, which include destruction and public auction, will depend on the types and nature of the confiscated goods. About 53 462 items of confiscated goods, which included cigarettes, optical discs, drugs, fuel oil, computer equipment, precious metals, vessels and vehicles were disposed of in 2023-24. The income arising from the Government's disposal of confiscated goods will go to the Treasury as revenue.

# Community and Youth



#### **C&ED Volunteer Team**

With the easing of the epidemic, the C&ED Volunteer Team has been actively participating in various types of volunteer activities, which have become more diversified. For instance, the Volunteer Team prepared love-packed meal boxes at a shared kitchen for delivery to grassroots families. They also joined hands with Suicide Prevention Services to visit elderly people who have been in emotional distress. Those elderly people were cheered up upon receiving the love-packed rice dumplings. Apart from caring for the grassroots in the community, the Volunteer Team also actively supported local sports events, including the Standard Chartered Hong Kong Marathon and the Community Chest's Walk for Millions.

The event successfully raised funds for the little warriors to strengthen patient support services and bring hope to them.

#### **Customs and Excise Band**

The Customs and Excise (C&E) Band is formed by a group of colleagues from different grades who are passionate about music. It aims to promote the fun of music among its members and provide professional band service for the Department's official and social functions.

The C&E Band participated in a total of five performances in 2023, including joint disciplined services events, departmental functions and community social events.





Being invited by the Fire Services Department, the C&E Band performed in the Fire Services passing-out parade for the first time in November 2023. They played Chinese military style music for Fire and Ambulance graduating trainees and guests.

The C&E Band performed several pieces of Chinese military style music at the Department's passing-out parade held in December 2023. They also formed a heart-shaped pattern showcasing the theme "Love Our Home, Treasure Our Country" and performed the song "My People, My Country".

## **Customs and Excise Pop Band**

The C&E Pop Band is formed by a group of Customs colleagues who have passions for popular music and band culture. It aims to promote music exchange and band culture. In addition to popular music, the Pop Band also explores different music genres such as jazz and rock.

The Pop Band hopes to create a platform that brings together colleagues who are interested in singing or playing musical instruments. Through various music activities, the Pop Band showcases members' diverse musical talents while fostering friendship among colleagues and enhancing unity and the Department's image.

#### **Customs YES**

C&ED introduced a new youth programme "Customs YES" in January 2021 with a view to fostering young people's positive values, law-abiding spirit as well as sense of belonging to society and our country through an array of diversified education-oriented activities with Customs nexus. As at the end of December 2023, Customs YES recruited over 5 500 individual members aged between 12 and 24 and 49 organisation members (including schools and non-governmental organisations).

The activities of Customs YES embrace four "C", namely "Calibre"; "Customs"; "Community" and "Country". The programme aims at helping young people enhance self-understanding, develop multi-talents, cultivate positive thinking while enhancing their understanding of C&ED's work and developing their sense of belonging to society, national awareness and patriotism through a variety of activities covering personal development, Customs work, career planning, community services and national education. In 2023, Customs YES organised over 180 activities with a total attendance of over 6 000.

To enhance Customs YES members' understanding of the latest developments of our country, C&ED organised four Mainland exchange and learning activities in 2023. These activities include an exchange tour to the Greater Bay Area in celebration of the 45th anniversary of the country's reform and opening-up, the Silk Road Summer Cultural Study Tour and a historical and cultural study tour to Hunan. Military Training Experience Camp was also held in Shenzhen to deepen members' understanding of national military culture.

#### **National Security Education Day**

C&ED has been playing an important role in safeguarding national security and is giving its full support to the National Security Education Day organised by the Committee for Safeguarding National Security of the Hong Kong Special Administrative Region. The open day featured a range of activities, including an exhibition on national security education to enhance public understanding of national security and introduce Customs' work and effectiveness in safeguarding national security. In addition, game booths were set up to introduce the Department's responsibility to perform its gatekeeping role in an interactive way.

Moreover, Guards of Honour and members of Customs YES participated in the flag raising ceremony held by the Security Bureau and its disciplinary forces and auxiliary services at the Hong Kong Police College on 15 April 2023. In addition, C&ED set up a booth to introduce the Department's multi-faceted work in safeguarding national security. The booth also won the Gold Award of the Disciplined Forces National Security Education Promotion Competition.





#### No. of Infringing Cases (2023 vs 2022)




#### Quantity of Infringing Articles Seized (2023 vs 2022)




# **Statistics on Forged Trademark Cases**

No. of Forged Trademark Cases (2023 vs 2022)




#### Value of Forged Trademark Goods Seized (2023 vs 2022)




# Result of Anti-cigarette Smuggling Operations

#### No. of Cigarette Smuggling Cases (2023 vs 2022)




#### Quantity of Smuggled Cigarettes Seized (2023 vs 2022)




### Result of Hydrocarbon Oil Enforcement Operations






### Range of Fines
